18. **OBSERVATIONS OF CWC – II HELD ON 16-08-2023:**

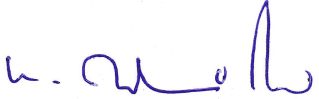
CWC – II Observed that both the participating contractors have fulfilled the eligibility conditions of the tender and the offers of both the participating contractors are technically acceptable.
