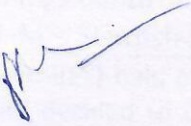
IV. OBSERVATIONS:

Among the 03(Three) technically acceptable contractors **M/s Bantu Suresh Goud Civil Contractor** is the lowest tenderer. He has quoted **Rs. 56,03,800.00** which is **(-) 18.47%** when compared to the estimated cost of **Rs. 68,73,125.00** based on MES SSR-2020 rates. However, L-1 firm has quoted **no freak rate**

V. DECISION OF CWC-I(FY) :

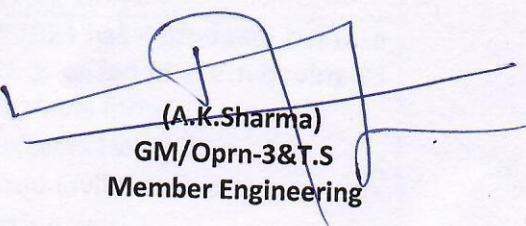
