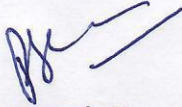

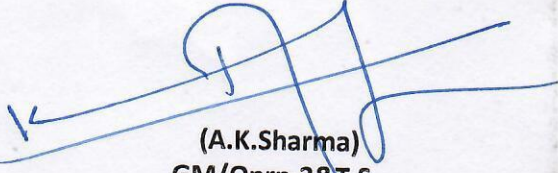
VIII. DECISION OF CWC-I(FY) :
