	1. It is observed that the work order for previous Term Contract for same work was placed with 18.18% below MES SSR 2020 on dtd. 20.05.2022. For subject work, L-1 Offer received from M/s Hindustan Construction Co, Ulhasnagar is 19.80% below MES SSR 2020. 2. It is observed that the L-1 Offer received for subject work is lower than the L-1 offer for previous Term Contract for same work. Hence the offer of L-1 Firm i.e. M/s Hindustan Construction Co, Ulhasnagar which is 19.80% below MES SSR 2020, is considered as reasonable and it is recommended to place the work order of subject work on L-1 Firm for 19.80% below MES SSR 2020.
