11. Deliberation/ discussion:

1. Total Five Firms participated in the subject Tender by submitting required EMD as per details mentioned under SI No. 9 above.
2. All the Five participated firms are found to be technically eligible as per Eligibility Criteria. Further as per Tender Condition, participating Firms are required to upload sealed and signed Declaration on Firm's Letterhead w.r.t. the Tender Documents mentioning that the 'Firm has read & understood all the conditions mentioned on each page of Tender Document, Instruction to Bidders, Eligibility Criteria, Technical Specifications & all other conditions before quoting for tender'.
3. It is observed that Three participating firms except M/s J. K. Enterprises, Ambarnath & M/s AGS Enterprises, Ambarnath have submitted the required declaration. It is noted that M/s AGS Enterprises, Ambarnath have uploaded old version of sealed & signed Tender documents & Technical Spec. for subject tender. Further it is noted that M/s J K Enterprises, Ambarnath have uploaded sealed & signed copies of all Tender related documents.
4. Hence EO Civil vide email Dtd. 24.08.2023 requested both firms to submit required sealed & signed declaration on their resp. Firm's letter head. In response M/s J. K. Enterprises, Ambarnath forwarded required declaration through email Dtd. 25.08.2023 & M/s AGS Enterprises, Ambarnath also forwarded required declaration through letter No. Nil Dtd. 24.08.2023 respectively.
5. Thus all Five participating Firms are technically eligible and also have fulfilled required criteria of uploading / submission of sealed and signed declaration w.r.t. Tender Documents. Hence it is recommended for opening the price bids of all Five participating firms.

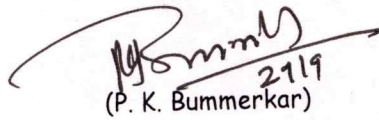
