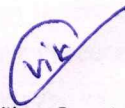

	1. The L-1 firm, M/s Hindustan Construction Co., Ulhasnagar has quoted Rs 39,92,671.20/- (Rs. Thirty Nine Lakh Ninety Two Thousand Six Hundred & Seventy One Rupees and paise Twenty only) through e-tendering which is 12.84 % Below Admin Approval Cost of Rs. 45.81 Lakh. 2. It is also observed that L-1 Firm has neither quoted any High Freak Rates nor any Low Freak rates based on the criteria for Freak rate as per Clause 10.5.3 of SOP for Civil works in AVNL & as per Point No. 1 of Appendix. 3.13 of MES Manual on Contract 2020. 3. The offer of L-1 Firm, for Rs. 39,92,671.20/- (Rs. Thirty Nine Lakh Ninety Two Thousand Six Hundred & Seventy One Rupees and paise twenty only) which is 12.84 % Below Admin Approval Cost of Rs. 45.81 Lakh, may be considered acceptable and work order may be placed on L-1 Firm M/s Hindustan Construction Co., Ulhasnagar.

	MTPF CWC-I (Fy) after detailed deliberations decided to place the work order for subject work on L-1 Firm M/s Hindustan Construction Co., Ulhasnagar for total amount of Rs. 39,92,671.20/- (Rs. Thirty Nine Lakh Ninety Two Thousand Six Hundred & Seventy One Rupees and paise twenty only).
