	1. The L-1 firm, M/s Ajay Enterprises, Ulhasnagar has quoted Rs. 71,36,285/- (Rs. Seventy One Lakh Thirty Six Thousand Two Hundred & Eighty Five only) through e-tenders.gov.in which is 25.06% Below Admin Approval Cost of Rs. 95.23 Lakh. Also the L-1 Firm has not quoted any High Freak Rates. However the L-1 Firm, has quoted Low Freak Rate for the Tender Item SI No. 2. 2. The scrutiny of Estimate is carried out in respect of item for which rate is freak and it is found that the quantity mentioned in the tender for this item on the basis of known facts is reasonably estimated. 3. The Offer of L-1 Firm M/s Ajay Enterprises, Ambarnath for Rs. 71,36,285/- (Rs. Seventy One Lakh Thirty Six Thousand Two Hundred & Eighty Five only) which is 25.06% below Admin Approval Cost of Rs. 95.23 Lakh, may be considered as reasonable and work order may be placed on L-1 Firm M/s Ajay Enterprises, Ulhasnagar with necessary declaration of Low Freak rate item so that this item shall not decrease beyond 5% of estimated quantity during execution of work, keeping in view provisions of Para 10.5.3 of SOP for Civil Works in AVNL or amendment thereto if any.

	MTPF CWC-I (Fy) after detailed deliberations decided to place the work order for subject work on L-1 Firm M/s Ajay Enterprises, Ulhasnagar for total amount of Rs. 71,36,285/- (Rs. Seventy One Lakh Thirty Six Thousand Two Hundred & Eighty Five only). Further it is also decided that the Quantity of Tender Item SI No. 2 shall not be executed less than 5% of the estimated quantity, keeping in view provisions of Para 10.5.3 of SOP for Civil Works in AVNL 2021 or amendment thereto if any in future.
