SUB :- CANCELLATION OF e-TENDER FOR CIVIL WORKs - REG.

The e-Tender for the following Civil work has been hosted in website (CPPP) <https://etenders.gov.in> under Two Bid system and Original BSCD & Technical bid opening dates were scheduled as tabulated below.

It is submitted that there is a feature of Bid Auto Extension Corrigendum in the CPPP portal wherein the tenders can be configured to be opened on receipt of specified number of bids and in the absence of the minimum configured bids the CPPP portal itself issues a Bid Auto Extension Corrigendum as per the configured Days for BSCD and TTOD. It is further submitted that there is no provision to view the number of bids which have been submitted against each tender in the CPPP e-procurement portal. In case of non-receipt of minimum configured bids Bid auto Extension corrigendum is issued by the servers on 03 iterations and in case of receipt of minimum configured bids the case is forwarded to bid openers login wherein the bids can be opened on the stipulated tender opening date and time and only then the total number of bids received against the tender are visible. After 03 Bid auto extensions the e-bids received (if any) are forwarded to the bid openers login. The Configuration of minimum number of bids and number of days to be extended in HVF tenders as configured is as follows ;

It is submitted that in the below mentioned case, the Original BSCD and Technical bid opening dates were as tabulated below. Since minimum configured number of bids / offers were not received, the CPPP portal has issued Bid Auto Extension Corrigendum on 03 Iterations. It is submitted on the 03rd extended bid submission date (29-09-2023) no further bid auto extension corrigendum has been issued by the portal since it is configured only for 03 Auto extensions. The EMD receipt status of the tenders On Opening of tender box on 29-09-2023 is tabulated below. The Number of e-bids received on technical bid opening date (ie) 30-09-2023 @ 1000 Hrs, in Bid openers login is also tabulated below. Since there is no response for this tender despite 03 extensions, it is proposed to cancel the present tender. Further it is submitted that the first tender for the subject work was cancelled as per decision of CWC-I held on 14-03-2023 and the case was re-tendered, as the addresses of both the participants were same in IT documents and the 2 participating contractors were related. The Second and third tender floated were also cancelled after 3 extensions due to non receipt of bids. Now, the fourth tender (present tender) for the work has also not yielded any bids as tabulated below. Hence it is proposed to drop the proposal for the work
