Vijayalakshmi Enterprises, Chennai, (iv) M/s. Sri Lakshmi Industries, Chennai and (v) M/s. S. Vinayagamurthy, Chennai have fulfilled the eligibility conditions of the tender and the offers of the 05 (Five) above mentioned contractors are technically acceptable.
- (ii) The Contractor M/s. Atthar Bai Timbers, Trichy has submitted Work Completion Certificates in the Name of M.Shaik Dawood from OFT, HAPP, EFA and Munitions India Limited. However in the CPPP Procurement Portal, Name of Bidder as well as Company Name is shown as Atthar Bai Timbers.
17. The Contractor M/s. Atthar Bai Timbers, Trichy submitted Work Completion Certificates in the Name of M.Shaik Dawood from OFT, HAPP, EFA and Munitions India Limited.
- It is submitted that CEO vide RFI dated 25-10-2023 requested the Contractor to clarify the same and in reply to the RFI the Contractor M/s. Atthar Bai Timbers, attached letter dated 27-10-2023 in which it is intimated that

ATTHAR BAI TIMBERS as known as M.SHAIK DAWOOD, Civil Contractor, Register Office Address No. 97/7, Madurai Road, Near Ramakrishna Theater, Trichy – 620008, Branch office: No. 18, 3rd Street, Sriivasa Nagar, Vayalur Road, Puthur, Trichy – 620017.*
- In the above clarification I am only the SOLE PROPRIETOR of the Company, I am only the authorized person of this company. This is for your kind information M/s. ATTHAR BAI TIMBERS AND M.SHAIK DAWOOD CIVIL CONTRACTOR both are same.*
- For your reference our submitted INCOME TAX RETURN is linked with my personal PAN – (SOLE PROPRIETORSHIP).*

18. **OBSERVATIONS OF CWC- I HELD ON 10-11-2023:**

- (i) CWC- I deliberated the case and observed that the Contractors; (a) M/s. B.V. Enterprises, Chennai, (b) M/s. Siva Enterprises, Chennai, (c) M/s. Vijayalakshmi Enterprises, Chennai, (d) M/s. Sri Lakshmi Industries, Chennai and (e) M/s. S.Vinayaga murthy, Chennai have fulfilled the eligibility conditions of the tender and the offers of the 05 (Five) above mentioned contractors are technically acceptable.

(ii) CWC – I Observed that the Contractor M/s. Atthar Bai Timbers, Trichy has submitted Work Completion Certificates in the Name of M.Shaik Dawood from OFT, HAPP, EFA and Munitions India Limited. However in the CPPP Procurement Portal, Name of Bidder as well as Company Name is shown as Atthar Bai Timbers. CEO vide RFI dated 25-10-2023 requested the Contractor to clarify the same and in reply to the RFI the Contractor M/s. Atthar Bai Timbers, vide letter intimated that

"..... I am M.SHAIK DAWOOD, S/o. Mr. Mohamed Kasim, Proprietor of M/s. ATTHAR BAI TIMBERS as known as M.SHAIK DAWOOD, Civil Contractor, Register Office Address No. 97/7, Madurai Road, Near Ramakrishna Theater, Trichy – 620008, Branch office: No. 18, 3rd Street, Sriivasa Nagar, Vayalur Road, Puthur, Trichy – 620017.

In the above clarification I am only the SOLE PROPRIETOR of the Company, I am only the authorized person of this company. This is for your kind information M/s. ATTHAR BAI TIMBERS AND M.SHAIK DAWOOD CIVIL CONTRACTOR both are same.

For your reference our submitted INCOME TAX RETURN is linked with my personal PAN – (SOLE PROPRIETORSHIP).

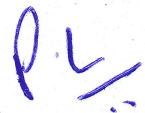
(iii) CWC – I Observed that as per the Eligibility conditions of the tender the Contractor must possess experience of having successfully completed similar work in Central / State Govt. Deptt & Undertakings / PSU's (Public Sector Undertakings) during last 07 (Seven) years and the applicant should have executed similar work to the appropriate value as per the above conditions (Similar work means Civil Works Only). However, the Contractor M/s. Atthar Bai Timbers, Trichy has not submitted any experience details in the Company Name and instead of the above requirement has submitted Work Completion Certificates in the Name of M.Shaik Dawood from OFT, HAPP, EFA and Munitions India Limited. Hence, the offer of the Contractor M/s. Atthar Bai Timbers, Trichy is not meeting the eligibility conditions of the tender and their offer is not acceptable.

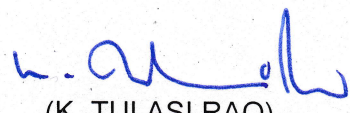
19. **DECISION OF CWC- I HELD ON 10-11-2023:**

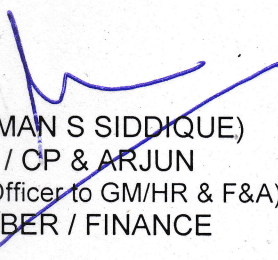
(i) CWC – I deliberated the case and observed that the following 05 (Five) Participating Contractors have fulfilled the eligibility Conditions of the tender and their offers are technically acceptable. Hence, CWC - I approved opening of e-price bids of the following 05 (Five) Participating Contractors viz.,

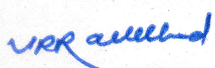
1. M/s. B.V. Enterprises, Chennai,
