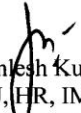

1. Firm at Sl. No. 01, M/s Deepesh Electricals, JBP has submitted EMD mentioned in the above table. During scrutiny for other documents as per bid requirement, it was observed that firm has not submitted proper documents for EPF registration, Working Capital Certificate, Solvency certificate and Local Content Certificate. Accordingly observation was raised on 24.04.2024 (Placed in file) through CPPP system for submission of deficient documents. Firm was given 07 days time to reply against the raised observation. In reply, firm submitted the proper documents for EPF registration and Local Content Certificate but not submitted proper documents for Working Capital Certificate and Solvency certificate. Subsequently second observation was raised on 07.05.2024. In reply firm has submitted proper document for Working Capital Certificate and Solvency certificate.

In view of the above, firm is meeting the required TE eligibility criteria.

2. Firm at Sl. No. 02, M/s Jaypee Enterprises, Bhandra has submitted EMD mentioned in the above table. During scrutiny for other documents as per bid requirement, it was observed that firm has not submitted proper documents for Registration/Enlistment Certificate, Working Capital Certificate, Solvency certificate, GST rate and HSN & SAC Code, Affidavit for Legal requirement, Local Content Certificate, T&C part-I, II, III & IV and Partnership deed. Accordingly observation was raised on 24.04.2024 (Placed in file) through CPPP system for submission of deficient documents. Firm was given 07 days time to reply against the raised observation. But firm did not respond. Again second observation was raised on 07.05.2024. In reply, firm submitted the proper documents for Legal Requirement (Affidavit), Part I, Part II, Part IV of T & C and Partnership Deed but not submitted proper documents for Registration/Enlistment Certificate, Working Capital Certificate, Solvency certificate, GST Rate and HSN & SAC Code, Local Content Certificate and Part III of T & C.

In view of the above, firm is not meeting the required TE eligibility criteria.

3. Firm at Sl. No. 03, M/s Kailash Enterprises, Bhilai has submitted EMD mentioned in the above table. During scrutiny for other documents as per bid requirement, it was observed that firm has not submitted proper documents for Working Capital Certificate, Solvency certificate, Applicable GST rate and HSN & SAC code, Local content certificate, T&C Part-IV and partnership deed. Accordingly observation was raised on 24.04.2024 (Placed in file) through CPPP system for submission of deficient documents. Firm was given 07 days time to reply against the raised observation. In reply, firm submitted the proper documents for working Capital Certificate, Solvency certificate, Applicable GST rate and HSN & SAC code, Local content certificate, T & C Part-IV and Partnership deed.

In view of the above, firm is meeting the required TE eligibility criteria.

4. Firm at Sl. No. 04, M/s Kamal Kishore Garg, Bhopal has submitted EMD mentioned in the above table. During scrutiny for other documents as per bid requirement, it was observed that firm has not submitted proper documents for Applicable GST rate and HSN & SAC code and Local content certificate. Accordingly observation was raised on 24.04.2024 (Placed in file) through CPPP system for submission of deficient documents. Firm was given 07 days time to reply against the raised observation. In reply, firm had not submitted proper document for Applicable GST rate and HSN & SAC code and Local content certificate. Subsequently second was raised on 07.05.2024. In reply firm has submitted proper document for GST Rate and HSN & SAC Code and Local content certificate.

In view of the above, firm is meeting the required TE eligibility criteria.

5. Firm at Sl. No. 05, M/s Brijesh Sonker, JBP has submitted EMD mentioned in the above table. During scrutiny for other documents as per bid requirement, it was observed that firm has not submitted proper documents for Registration/Enlistment certificate. Accordingly observation was raised on 24.04.2024 (Placed in file) through CPPP system for submission of deficient documents. Firm was given 07 days time to reply against the raised observation. But firm did not respond. Again second observation was raised on 07.05.2024 but firm has not responded second time also.

The submitted work completion certificate is completing the required criteria after enhancing the actual value of work at simple rate of 7% per annum calculated from the date of completion to the date of Bid opening 01/04/2024 as per the Manual for Procurement of Works (Updated June, 2022) Chapter 3, Point No 3.3.6 part issued by Government of India, Ministry of Finance, Department of Expenditure (Copy enclosed). In view of the above, firm is meeting the required TE eligibility criteria i.e two work completed of 50% of the tender value i.e Rs 1,99,39,492.85. The calculation for the same is mentioned in the table below: -

Accordingly was raised on 24.04.2024 (Placed in file) through CPPP system for submission of deficient documents. Firm was given 07 days' time to reply against the raised observation. In reply, firm submitted the proper documents for GST certificate, Working Capital Certificate and Partnership deed.

In view of the above, firm is meeting the required TE eligibility criteria.

7. Firm at Sl. No. 07, M/s J P Enterprises, JBP has submitted EMD mentioned in the above table. During scrutiny for other documents as per bid requirement, it was observed that firm has not submitted proper documents for Solvency certificate, Applicable GST rate and HSN & SAC code and Local content certificate. Accordingly observation was raised on 24.04.2024 (Placed in file) through CPPP system for submission of deficient documents. Firm was given 07 days time to reply against the raised observation. But firm had not responded. Again second observation was raised on 07.05.2024 but firm has not responded second time also.

In view of the above, firm is not meeting the required TE eligibility criteria.

8. Firm at Sl. No. 08, M/s Rajkumar Gupta Contractor, JBP has submitted EMD mentioned in the above table. During scrutiny for other documents as per bid requirement, it was observed that firm has not submitted proper documents for working capital certificate. Accordingly observation was raised on 24.04.2024 (Placed in file) through CPPP system for submission of deficient documents. Firm was given 07 days time to reply against the raised observation. In reply, firm submitted the proper documents for Working Capital Certificate.

In view of the above, firm is meeting the required TE eligibility criteria.

Eligibility criteria as mentioned in the tender

Firm Registration, EPF, ESIC and GST registration. For electrical work, Electrical license is also required.

Turn over: Average Annual Turnover during last Three (03) years, ending 31st march of the previous financial year will be at least 30% of the estimated cost. The bidder's financial capability will be decided based on the average annual turnover.

Solvency certificate: The firm should be solvent to an amount equal to or greater than 1/3 of the estimated cost OR Financially sound for engagement equal to or greater than the estimated cost.

Working capital certificate: Working capital certificate for (a) Estimated cost up to 60 Lakhs – not less than 1/10 of the estimated cost.

(b) Estimated cost above 60 Lakhs – not less than 7.00 Lakhs.

Note: Solvency certificate and Working capital certificate from scheduled bank to be enclosed. Working Capital Certificate & Solvency certificate having validity on bid submission end date (validity must be clearly mentioned in certificate).
