Three similar works each costing not less than 40% of the estimated cost. (Rs. 41.60 Lakhs)

b)

Two similar works each costing not less than 50% of the estimated cost. (Rs. 52.00 Lakhs)

c)

One similar work costing not less than 80% of the estimated cost. (Rs. 83.21 Lakhs)

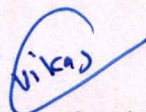

11. Deliberation/Discussion

1. Total Three Firms participated in the subject Tender by submitting required EMD as per details mentioned under SI No. 9 above.
2. The firms, M/s Golden Construction, Kalyan, M/s Vandan Enterprises, Ambernath & M/s Hitech Buildcon, Vasind were requested to submit documents as per Eligibility Criteria, which were not uploaded during online tender submission. The same is illustrated under Point 10 (A) & 10 (B) above.
3. Further as per Tender Condition, participating Firms are required to upload sealed and signed Declaration on Firm's Letterhead w.r.t. the Tender Documents mentioning that the 'Firm has read & understood all the conditions mentioned on each page of Tender Document, Instruction to Bidders, Eligibility Criteria, Technical Specifications & all other conditions before quoting for tender'.

	4. It is observed that M/s Vandan Enterprises Ambernath has not uploaded required declaration. 5. Hence EO Civil vide email Dtd. 31.01.2024 requested to M/s Vandan Enterprises Ambernath to submit required sealed & signed declaration on Firm's letter head. In response M/s Vandan Enterprises Ambernath handed over hard copy of required declaration (<u>case files Pg. No. 119</u>). 5. Thus all three participating Firms namely M/s Golden Construction, Kalyan, M/s Vandan Enterprises, Ambernath & M/s Hitech Buildcon, Vasind have fulfilled required criteria of uploading / submission of sealed and signed declaration w.r.t. Tender Documents. Hence, it is recommended for opening the price bids of all three technically eligible participating firms namely M/s Golden Construction, Kalyan, M/s Vandan Enterprises, Ambernath & M/s Hitech Buildcon, Vasind.

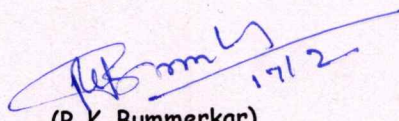
