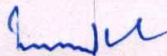

1.The L-1 firm, M/s Nikhil Mallappa Sangolikar, Ambarnath has quoted Rs.14,39,030/- (Rs. Fourteen Lakh Thirty Nine Thousand & Thirty only) through e-tenders.gov.in which is 26.73% Below Admin Approval Cost of Rs. 19.64 Lakh. Also the L-1 Firm has quoted High Freack Rates for the Tender Item SI No. 03 & 12. Further the L-1 Firm has quoted Low Freack Rates for the Tender Item SI No. 2, 5, 6,7,8,10,14 & 15.

	2. As per decision of MTPF/CWC-II (Fy) Dtd. 06.02.2024, a letter was sent to M/s Nikhil Mallappa Sangolikar, Ambernath (L-1) through email Dtd. 06.02.2024 requesting Firm to quote Rock Bottom Prices for Tender Items for which rates quoted are freak high. Further L-1 Firm was also requested to submit the Undertaking stating that Firm has understood the scope of work and shall execute the work for Low Freak rate items at quoted rates to the entire satisfaction of the Factory Authorities. 3. The L-1 Firm vide email Dtd. 06.02.2024 submitted that 'it is our present market cost price which is minimum cost price & competitive/ reasonable price can't be reduced. We will complete satisfactory as your scope with excellent quality. We have understood the scope of work and shall execute the work for their items at quoted rate to the entire satisfaction of the factory authorities. Further L-1 Firm also confirmed that Firm is ready to carry out the work for referred items under freak low category to the extent of Tender quantity and tender specification to the entire satisfaction of Factory authorities. Thus the L-1 Firm M/s Nikhil Mallappa Sangolikar, Ambernath declines to reduce the rates for the Tender Items for which High Freak rates are quoted. 4. Considering the overall quotation the offer of L-1 Firm of Rs. 14,39,030/- (Rs. Fourteen Lakh Thirty Nine Thousand & Thirty only) which is 26.73% below the Admin Approval cost of Rs. 19.64 Lakh may be considered as reasonable & work order may be placed on L-1 Firm M/s Nikhil Mallappa Sangolikar, Ambernath (L-1) with necessary declaration of High & Low Freak rate item so that these items shall not be increased / decreased beyond 5% of their estimated quantities during execution of work, keeping in view provisions of Para 10.5.3 of SOP for Civil Works in AVNL or amendment thereto if any.
15.	Decision:- MTPF CWC-II (Fy) after detailed deliberations decided to place the work order for subject work on L-1 Firm M/s Nikhil Mallappa Sangolikar, Ambernath for total amount of Rs. 14,39,030/- ((Rs. Fourteen Lakh Thirty Nine Thousand & Thirty only). Further it is also decided that the Quantities of Tender Item Sl No. 03 & 12 shall not exceed beyond 5% of the estimated quantities during execution of the work and the Quantity of Tender Item Sl No. 2, 5, 6, 7, 8, 10, 14, 15 shall not be executed less than 5% of the estimated quantity, keeping in view provisions of Para 10.5.3 of SOP for Civil Works in AVNL 2021 or amendment thereto if any in future.
