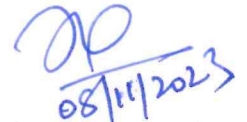

In order to facilitate contract management and ensure timely processing of requests made by the vendor, DMRC has implemented the Vendor Payment Portal that will allow the vendor to register themselves, raise payment requests, modify vendor information and request variation in contract. 6. You will get the message "Your request has been sent to the nodal officer for verification. Once verified, you will receive notification via email and sms."
