



SUB: CANCELLATION OF TENDER VIDE NIC TENDER ID: 2023 GAIL 163309 1 FOR “RENOVATION AND EXTENSION OF CANTEEN IN TECHNICAL BUILDING AT GAIL VIJAIPUR.”

Upon further evaluation of the bids received by tender committee, none of the participated bidders were qualified techno-commercially against NIC TENDER ID: 2023_GAIL_163309_1 Dated 07.08.2023 as detailed below.

REASON FOR REJECTION:

[1/4] M/s. Pramod Bahl And Company:

Technical Reasons: Bidder has submitted a copy of Final Deviation of contract with REF No. UPL/TTPS/2023/966 dated 11.08.2023 issued by M/s Utility Powertech Limited for the Works "Maintenance contract for civil works in Township and other areas of TTPS mn". However, submitted work order does not contain the scope of civil construction works including works like Flooring, False ceiling, Furniture works, Plumbing works etc to substantiate BEC-technical criteria of the tender. As such bidder is not meeting BEC-technical criteria of the tender.

Commercial Reasons: Authenticated UDYAM certificate by CA & Notary, audited financial statements duly notarized and duly filled & signed formats F-1, F-2A, F-5 have not been uploaded by the bidder, however, bid is considered unresponsive without making further queries because bidder has not been qualified BEC-technical criteria.

In view of the above stated reasons, bid is not acceptable techno-commercially.

[2/4] M/s. Swanip Infracon Private Limited:

Technical Reasons: In format F-7, bidder has mentioned that

However, the copy of detailed work order and its completion/execution proof were not been submitted by the bidder even after query. As such bidder is not meeting BEC-technical criteria of the tender.



Commercial Reasons: audited financial statements duly notarized and duly filled & signed format F-10 have not been uploaded by the bidder, however, it was mentioned in the format F-8 that audited financial statement for relevant financial year are submitted, accordingly, query was raised to submit the audited financial statements and format F-10. However, audited financial statements and format F-10 have not been submitted by the bidder even after query to substantiate BEC-financial criteria of the tender. As such bidder is not meeting BEC-financial criteria of the tender.

In view of the above stated reasons, bid is not acceptable techno-commercially.

[2/4] M/s. PN Rathi:

Commercial Reasons: EMD/bis security has not been submitted by the bidder rather sought exemption under MSE category and submitted the relevant Udyam certificate UDYAM-MP-19-0005060 dated 14.01.2022 which stipulates that major activity of the bidder as **Services (Trading)** (refer Pg-300).

- As per clarification issued by MSME dept vide letter ref: F.No.21(6)/2020-MA(E-4016565 dated 31.08.2023, if the major activity of the MSE is Services (Trading) then the unit is not eligible for availing the benefits of the Public Procurement Policy for MSEs Order, 2012 (refer Pg-349)
- As per clause no.16.9 of the ITB (section-III) of the tender, traders/dealers are not entitled for exemption of EMD.
- The corrected Udyam certificate dated 08.11.2023 submitted by the bidder through email is post final bid due date i.e. 31.08.2023 and same certificate cannot be considered as a valid document for availing EMD exemption against instant tender.

Therefore, bid is not acceptable commercially due to non-submission of EMD.

[4/4] M/s. Shri Morvinandan Enterprises LLP:

Technical Reasons: Bidder has submitted a copy of Letter of Acceptance with LOA No. GAIL/VH/C21286/5300036670/CIVIL/ST dated 30.04.2022 issued by M/s GAIL (India) Limited for the Works "Construction of Modular Kitchen Facilities in GAIL Township Vijaipur" with awarded value of Rs 2,15,89,186.20/- (incl. GST). However, submitted work order does not contain the scope of civil construction works including works like Flooring, False ceiling, Plumbing works etc to substantiate BEC-technical criteria of the tender. As such bidder is not meeting BEC-technical criteria of the tender.

Commercial Reasons: Bidder is having average turnover of Rs. 35.56 Lakhs against tender requirement of Rs. 37.61 Lakhs. As such bidder is not meeting BEC-financial criteria of the tender.

In view of the above stated reasons, bid is not acceptable techno-commercially.
