2.2 REASON FOR REJECTION:

1. M/S ANJALI CONSTRUCTION-

Technical Criteria :

- Bidder has not submitted execution certificates attested by Chartered Engineer and notary public with Legible Stamp also Bidder has not submitted work orders against uploaded completion certificates even after query. Hence BEC Criteria not complied.
- Bidder has not uploaded signed copy of SCC, Scope of work & other Technical specifications.

Financial Criteria :

- Audited Annual Financial Statement of FY 2020-21 duly certified by CA and Notary Public with Legible stamp not submitted.

Commercial Criteria :

- Incomplete Format F-1 "Bidder's General Information" submitted.
- Incomplete Format F-5 "Agreed Terms & Conditions" submitted.
- Land border format Form-I-B to Section II & Form-II not submitted.
- Duly Signed copy of Integrity Pact by both the partner is not submitted.

For the above, TQ/CQs were raised to bidder, for which reply not received within the scheduled date of response of query. Hence bidder is techno-commercially not acceptable.



2. M/S RAJENDRA KUMAR-

Technical Criteria :

- (a) Bidder has not uploaded any work order towards BEC compliance, instead, has uploaded start up certificate of recognition, which is not applicable for this tender.

Financial Criteria :

- (a) FORMAT F-10: Format for Chartered Accountant Certificate for Financial Capability of the Bidder not uploaded.

Commercial Criteria :

(b) Forms & Formats not submitted.

EMD not submitted, Hence bidder is commercially not acceptable.

3. M/S JANTA ENGINEERS & COMPANY-

Technical Criteria :

- (a) Bidder has uploaded Power Grid Corporation of India Limited Letter of acceptance no. NR-III/5002002168/LOA/K00/1403/30937 SAP PO:4100004867 Doc. dtd. 27.05.2022, but neither submitted its completion nor execution certificate not also certified by Chartered Engineer and attested by Notary Public with legible stamp as per BEC requirement.
(b) Bidder has not uploaded signed copy of SCC, Scope of work & other Technical specifications.

Financial Criteria :

- (a) Net worth and working capital documents not submitted.
(b) Uploaded Audited Annual Financial Statement of FY 2020-21, FY 2021-22 & FY 2022-23 with duly certified by Chartered Accountant but without Notary Public with Legible stamp submitted.
(c) FORMAT F-10: Format for Chartered Accountant Certificate for Financial Capability of the Bidder not uploaded as per GAIL format.

Commercial Criteria :

- (a) EMD Not Submitted

EMD not submitted, Hence bidder is commercially not acceptable.

4. M/S S.S ENTERPRISES-

Technical Criteria :

- (a) Bidder has uploaded P.C Snehal Construction Private Limited's LOA no. Nil dtd. 14.06.2019 for the work "Project of Lowering, Laying, jointing, testing and commissioning of DI pipe & HDPE pipes for water supply Scheme at Rahogarh Town for MPUDC 41 Project in Madhya Pradesh" & P C Snehal Construction Private Limited's LOA no. NIL dtd. 29.10.2020 for the work "HDPE pipelines for Water Supply Scheme under UIDSSMT at Nagar palika, Rajgarh (M.P.) Water Supply Project" but not mentioned work orders value and not contains detailed SOR. as per tender BEC.
(b) Bidder has uploaded P.C Snehal Construction Private Limited's LOA no. NIL dtd. 29.10.2020 for the work "HDPE pipelines for Water Supply Scheme under UIDSSMT at Nagar palika, Rajgarh (M.P.) Water Supply Project" but neither submitted its execution nor completion certificate as per tender BEC.

- (c) Bidder has uploaded execution/completion certificate of 2 work orders (i). P C Snehal Construction Private Limited's LOA no. Nil dtd. 14.06.2019, (ii) WPIL Ltd.'s Work Order no. 88WO/21-22/0107 dtd. 10.01.2022 (Amended-06, 19-09-2023) which are not issued by End User/owner/consultant along with other specified documents as per tender BEC.

- (d) Bidder has not uploaded signed copy of SCC, Scope of work & other Technical specifications.
