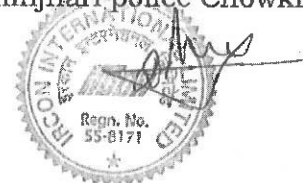
1.0 Your offer at 6.50% below the estimated cost for the work " Providing utility service for office work, housekeeping facilities at project Guest House and offices of IRCON in connection with Katni Grade Separator Bypass Line Project for the period of 12 months" submitted vide references above, has been accepted by the competent authority of Ircon International Limited at a total cost of Rs. 33,23,240.58 (Rupees Thirty-Three Lakhs Twenty-Three Thousand Two Hundred Forty and Fifty-Eight Paise only) inclusive of agency service charge, GST @ 18% and all other taxes, duties, etc., at the rates of items/schedules as per Annexure "A" (attached herewith) to this letter and terms & conditions, incorporating all the corrigendum's issued to the tender documents.

2.0 Taxes will be paid as applicable from time to time as notified by the Government.



- 3.0 In terms of para 7.1 of Special Condition of Contract, you are requested to submit a Performance Guarantee (P.G) in the form of irrevocable bank guarantee on the Performa annexed as Annexure-XII of the tender document from any Scheduled Bank for an amount of 5% (Five percent) of the contract value i.e., Rs. 1,66,102/- (Rupees One Lakh Sixty-Six Thousand One Hundred Two only).
- 4.0 The completion period of work is 12 (twelve) months from the date of issue of this LOA.
- 5.0 In terms of clause 7.2 (Retention Money) of Special Condition of Contract.
- 5.1 Retention money for all contracts shall be recovered from on account/final bills of the contractor @ 10% of gross value of each bill, till the amount so recovered including EMD amount adds unto 5% of the contract value of the work.
- 5.2 No interest shall be payable to the Contractor on the amount retained in cash towards retention money.
- 6.0 You are requested to attend this office for signing of the Contract Agreement within 28 days after issue of this letter as per clause no, 13.5 of Special Condition of Contract (Part-I).
- 7.0 All other terms and conditions shall be as per Tender Documents and Corrigendum's, which shall form an integral part of this contract and shall be binding on you. Your letter at reference above shall form part of the Contract Agreement. This letter of acceptance, along with your submitted offer, shall constitute a binding contract between you and Ircon International Limited, till a formal agreement is drawn and executed.
