In reference to the tender document and your offer referred above, Ircon International Limited is pleased to accept your offer for "Erection, Testing and Commissioning of Active Power Filter (APF) System for Ghaziabad RSS and Murad Nagar RSS in connection with Delhi - Ghaziabad - Meerut RRTS Corridor of NCRTC (Package-19 Lot-1 & Lot-2)" on the following Terms & Conditions:
2. **Total Cost of Work: Rs. 37,62,979.17/-** (Rupees Thirty-Seven Lakh Sixty-Two Thousand Nine Hundred Seventy-Nine and Seventeen Paise only) inclusive of all taxes & duties and GST @18% in accordance with tender terms and conditions issued vide ref. (i) above. TDS, GST-TDS or any other taxes as applicable shall be deducted from the RA bill. Taxes, duties & Levies shall be governed in accordance with clause no. 18 of SCC. Detailed Bill of Quantities (BOQ) is enclosed as **Annexure-I**.
3. In terms of Clause 12 of Special Conditions of Contract (SCC), the date of issuance of this Letter of acceptance shall be the date of commencement of work.
4. **Completion Period:** The Contractor shall be required to complete the entire work within 3 (three) weeks from the date of issue of Letter of Acceptance (LOA).
5. **Payment Terms:** Payment against the work shall be made in accordance with Clause 27 of Special Conditions of Contract.
6. Defect Liability Period shall be 24 Months & commence from the date of Revenue Operation Date (ROD) in accordance with Clause 31 of Special Conditions of Contract.



7. In terms of Clause 29 of SCC and Clause 8.1 of GCC, Performance Security for an amount of 5% of the contract value i.e. **Rs. 1,88,200/-** (Rupees One Lakh Eighty-Eight Thousand Two Hundred only) shall be submitted to the office of Chief General Manager (Electrical)/IRCON International Ltd., C-4, District Centre, Saket, New Delhi, within 21 days of issuance of this letter.
8. This letter will constitute a legal and binding contract between Ircon International Limited and M/s Hitech Erectors Pvt. Ltd. till such time the formal contract agreement is signed.
9. You will enter into and execute the contract agreement within 28 days from the date of issue of this letter with Chief General Manager (Electrical)/IRCON International Ltd., C-4, District Centre, Saket, New Delhi-17. You are requested to arrange the stamp papers of requisite value as per the prevailing laws for signing of the agreement in terms of Clause 12.5 of General Conditions of Contract.
10. You are requested to contact immediately to Chief General Manager (Electrical)/IRCON International Ltd., C-4, District Centre, Saket, New Delhi-17, for execution of works under this contract.
11. All other terms and conditions shall be as per the tender document.
