Tender through CPP portal for the work of Hiring of Vehicle on Monthly Basis at IWAI, H.O. published on 23.05.2023 vide tender no. TENDER No. IWAI-11013/01/2023- Admin on CPP portal. Subsequently, the bids were opened on 15.06.2023 at 1530 hrs by the committee nominated vide office order dated 21.07.2023 and following 07 nos bidders have submitted their bids.

- a. M/s Aroon Aviation services Pvt Ltd.
- b. M/s Ambe Travels
- c. M/s Prem Tourist Taxi Services
- d. M/s Glorious India Travels
- e. M/s GS Tours and Travels
- f. M/s Veekay Cranes and Cabs Pvt Ltd
- g. M/s Surjit Tourist Taxi Services

Technical bids of the above firms were opened online on 15.06.2023. The based on the documents submitted by all firms, a statement have been prepared for all seven firms and placed at Annex - I. Upon thorough evaluation during the Technical Evaluation Committee (TEC) meeting held on 01.08.2023, it was identified that all above mentioned firms did not provide all the necessary documents in accordance with the tender conditions. In response, the TEC decided to request the shortfall documents from the all firms, vide letter IWAI/HQ/ADMN/VEH/2023 dated 03.08.2023, with a stipulated deadline of 10 days from the date of issuance. 07 bidders, the following 06 firms promptly responded and submitted the documents (Recommendation of TEC enclosed as an Annex – A).

- 1) M/s Aroon Aviation services Pvt Ltd.
- 2) M/s Ambe Travels
- 3) M/s Prem Tourist Taxi Services
- 4) M/s GS Tours and Travels
- 5) M/s Veekay Cranes and Cabs Pvt Ltd
- 6) M/s Surjit Tourist Taxi Services

After verification and evaluation of all documents, the observation of TEC are as follows (Evaluation document sheet is enclosed as an Annex – B):

M/s Glorious India Travels and M/s G. S. Tours and Travels have not submitted all required documents. M/s Aroon Aviation services Pvt Ltd. was blacklisted / debarred by Moradabad Railway Division for a period of 2 years from 18.08.2020. As per tender clause “2(j)” under “Technical Bid qualification criteria for the bidder” stipulating that “The bidder should not have been ‘blacklisted’ by any of the his existing/ past clients, especially any Government Department/ organizations, in the last 10 years for defective/ deficient service or any such reason related to providing vehicle service provided by him. He shall submit a declaration to this effect given in the technical bid formant”. As per legal opinion provided by Legacy Law Offices vide letter dated 10.08.2023 (Annex – C) the firm being blacklisted/ debarred by Moradabad Railway Division for a period of 02 years from 18.08.2020 may be considered as disqualified. Therefore, TEC has recommended technically qualified to following four firms and also recommends to opening of the financial bids of following four firms:

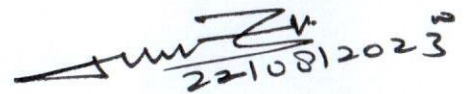
