

Recommendation of TEC on Financial bid of tender for "Work contract for supervision, monitoring and others related works/ services for various developmental works in Faizabad to Ghaghra - Ganga confluence at Manjhi Ghat stretch of River Ghaghra (NW-40)" which opened on 20.09.2023.

The e-tender were invited in two cover system through on line (cover - 1: technical bid and cover-2: financial bid) by IWAI Patna vide e-tender no. -IWAI/Patna/Admn/Ghaghra (NW-40)/ES&M/Tender/2023-24 for above works. The above NIT was published in two news papers namely Times of India (English) and 2. Hindustan (Hindi) for publicity and also uploaded on IWAI's Website and CPP portal for giving wide publicity. As per the NIT, the tender documents were submitted on line by the bidder on 21.07.2023 at 15:00 Hrs. Technical bids were opened on 22.07.2023 at 15:30 hrs.

1. The following firms submitted the bids online by closing date and time.
 - i. M/s MS SUBIR PAUL CHOWDHURY, Kolkata
 - ii. M/s Durgawati Enterprises Pvt. Ltd., Hajipur
2. The Technical bids opened on 22.07.2023. Based on the documents submitted by both the bidders and evaluation of technical bids by the TEC, it was found that following two bidders are technically qualified.

- i. M/s MS SUBIR PAUL CHOWDHURY, Kolkata
- ii. M/s Durgawati Enterprises Pvt. Ltd., Hajipur

TEC, accordingly, recommended to open the financial bids of above mentioned technically qualified bidders.

3. Financial bids of 02 no. technically qualified bidders opened on 20.09.2023 and financial evaluation has been carried out as per the criteria mentioned in the tender document. Accordingly, the statement of marks has been prepared as Annex.- 'A'.
4. Based on the score/marks obtained, TEC recommends to award the work of "Work contract for supervision, monitoring and others related works/services for various developmental works in Faizabad to Ghaghra-Ganga confluence at Manjhi Ghat stretch of River Ghaghra (NW-40)" who score the highest marks and placed at Rank-1 as per Annex.- 'A'.

Hence, TEC recommends to award the work to Rank-1 bidder i.e M/s Durgawati Enterprises Pvt. Ltd., Hajipur at a total cost of Rs. 18,75,984/- (including service charge and excluding GST) for the work of "Work contract for supervision, monitoring and others related works/ services for various developmental works in Faizabad to Ghaghra - Ganga confluence at Manjhi Ghat stretch of River Ghaghra (NW-40)".
