Reference to above, IWAI pleased to award the work order for engagement of skilled crew for operation, safety and maintenance of vessels of IWAI for the period of 8 months w.e.f 01/12/2023 for Kolkata- Kahalgaon Stretch of NW-01 (River Ganga) at total cost of Rs.2,56,67,709.00/- (Two Crore, Fifty Six Lakhs, Sixty Seven Thousand, Seven Hundred and Nine Only) excluding GST, in accordance with the above under reference no.1, tender terms & conditions with the following salient features:

## 2. PRICE:

The work value for engagement of vessel crews shall be Rs. 2,56,67,709.00/- (Wages amount Rs.2,17,52,296 + Service Charge on percentage 18% ) excluding GST, for engagement of skilled crew for IWAI vessels, Terminal Pontoons and cargo vessels for the period of 8 months for Kolkata- Kahalgaon Stretch of NW-01 w.e.f supply of crews subject to pro-rata basis as per written order of EIC when applicable. The above-mentioned total cost is inclusive of consolidated salary, service charges, taxes, ESI, EPF, and all statutory dues etc as specified in the General Conditions of the contract excluding GST.

The payment will be made on running account bills on monthly basis as per the clause no. 33.1, page 81 of the General Conditions of Contract and the final payment will be made as per the Finality clause no. 38, page 83.

**4. PERFORMANCE GUARANTEE/ SECURITY DEPOSIT:**

Rs. 12,83,385/- (Rupees Twelve Lakh Eighty Three Thousand Three Hundred and Eighty Five Only) being the 5% of the tendered value shall be deposited as security deposit for the due fulfillment of the contract in the form of RTGS / NEFT on any Nationalized Bank or Scheduled Bank of India or any other internationally reputed Bank in favor of "Inland Waterways Authority of India Fund" payable at Kolkata State Bank Of India, Garden Reach Road, Kolkata, Bank A/c no. 31661496517, IFSC Code SBIN0001402 as per Clause 4 of the General Conditions of Contract. The security deposit i.e. 5 % of the tendered value shall be deducted from each bill @ 10% of running bill amount till the sum along with the sum already deposited as the EMD will amount to security deposit of 5% of the contract value of work. **7. NUMBER OF CREW DEPLOYMENT:**

As per contract Section-VIII, Annexure IX page no 104, the EIC reserves the right to increase or decrease the number of crew as per requirement of IWAI. As per contract section VI terms of reference, the number of crew to be deployed along with remuneration is specified in clause 10 Page 56.

The agreement shall be signed within ten days from the date of receipt of work order. 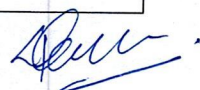
