(b) **M/S Milan Marine Service 28, Marquis Street, Kolkata -700016**

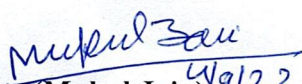

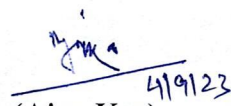
(d) **M/S Allied Technologies, Z3/103/8/A, Jelipara Road, Kolkata**
