- (b) M/S Atanu Ganguly 1/1A, Vansittart Row, Room No. 7, 1st Floor, Kolkata-700001

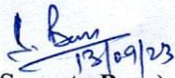

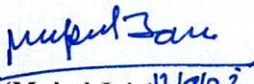
(c) **M/S Milan Marine Service 28, Marquis Street, Kolkata -700016**

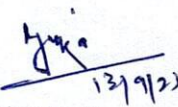
