(4) Observation of TEC:

(a) M/S Maa Vindhyawasni Enterprises

On scrutiny it is observed that M/S Maa Vindhyawasni Enterprises has submitted all the relevant documents in support of their MSME registration, detail Audited balance sheet, solvency certificate, experience in similar works, similar work completion certificate etc. The firm has been considered technically qualified. Accordingly financial bid was opened on dated 27.09.2023. Based on Comparative statement, M/S Maa Vindhyawasni Enterprises (L-2) has quoted Rs.4,05,844.00 which is lower (-3.60%) than estimated cost.

(b) M/s French Enterprise

On scrutiny it is observed that M/s French Enterprise has submitted all the relevant documents in support of their MSME registration, detail Audited balance sheet, solvency certificate, experience in similar works, similar work completion

certificate etc. The firm has been considered technically qualified. Accordingly financial bid was opened on dated 27.09.2023. Based on Comparative statement, M/s French Enterprise (L-3) has quoted Rs. 4,29,420.00 which is higher (+2.68%) than estimated cost.

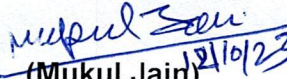
(c) **M/S Sabita Udyog**

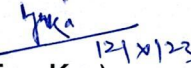
On scrutiny it is observed that M/S Sabita Udyog has submitted all the relevant documents in support of their MSME registration, detail Audited balance sheet, solvency certificate, experience in similar works, similar work completion certificate etc. The firm has been considered technically qualified. Accordingly financial bid was opened on dated 27.09.2023. Based on Comparative statement, M/S Sabita Udyog (L-1) has quoted Rs. 3,14,698.00 which is lower (-25.25%) than estimated cost.

(5) **Recommendation:**

Reference above, a justification letter dated 29.09.2023 was issued to M/s Sabita Udyog as the firm quoted less (-25.25%) than estimated cost. In this regards a letter dated 10.10.2023 is received by the M/s Sabita Udyog vide which it is stated that " the firm assured to complete the job according to the BOQ with maintaining good quality and also finish the job in stipulated period without any delayed".

TEC recommends that work may be awarded to L-1 bidder i.e. M/s Sabita Udyog, HOWRAH at the quoted price of Rs. 3,14,698.00 (excluding GST) plus cost of spares on actual + 10% basis with approval of Competent Authority.
