NIT was published in the daily newspapers for repair of IWAI Vessel AB Rajrambha for the year 2023-24, on 23rd September 2023 and also published on the IWAI website and e-procurement portal. In response to NIT, the following 03 parties are submitted their offers on the scheduled date and time i.e., 6th October 2023 at 1500 hrs, which is the last date of submission of the offers:-

1. M/s Maa Vindhyawasni Enterprises, Patna.
2. M/s Das Consultancy & Agency Service, Guwahati
3. M/s Ghosh Enterprises, Kolkata

A comparative statement has been prepared and enclosed herewith as Annex-1.

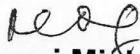
All the bidders are registered under MSME, therefore tender cost and required EMD have not been submitted. All other documents have been submitted with their offers.

All the firms have accepted the terms and conditions of the contract.

During the technical evaluation of the bids, it was observed that, M/s Ghosh Enterprises, Kolkata has not submitted the three years annual turnover CA Certificate & Bank solvency certificate. In this regard, a short fall corrigendum has been uploaded on e-procurement portal. Thereafter, M/s. Ghosh Enterprises has not provided Bank Solvency certificate as per tender. Therefore, M/s. Ghosh Enterprises is not technically qualified. Hence, the following two bidders are found technically qualified:

1. M/s Maa Vindhyawasni Enterprises, Patna.
2. M/s Das Consultancy & Agency Service, Guwahati

In view of the above, Committee recommends that the financial bids of above mentioned two bidders may be opened.

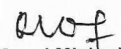

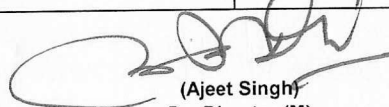
