On scrutiny it is observed that M/s GHOSH ENTERPRISE has submitted all the relevant documents in support of their MSME registration, detail Audited balance sheet, solvency certificate, experience in similar works, similar work completion certificate etc. The firm may be considered technically qualified.

(c) M/s SABITA UDYOG

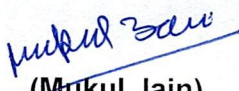

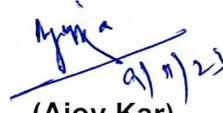
(d) **M/s RUPNARAYAN MARINE WORKS**
