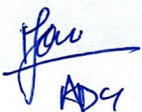
(4) Observation of TEC:

(a) M/s DAS ENTERPRISES

On scrutiny it is observed that M/s DAS ENTERPRISES submitted MSME certificate UDYAM-WB-13-0009195 which is not register for Mechanical equipments/ vessel related works, Therefore, the firm has not technically qualified.

(b) M/s GHOSH ENTERPRIS

On scrutiny it is observed that M/s GHOSH ENTERPRISE has submitted all the relevant documents in support of their MSME registration, detail of audited balance Sheet, solvency certificate, experience in similar works, similar work completion certificate etc. Therefore, the firm may be considered technically qualified.

On scrutiny it is observed that M/S MAA VINDHYAVASNI has submitted all the relevant documents in support of their MSME registration, detail Audited balance sheet, solvency certificate, experience in similar works, similar work completion certificate etc. The firm may be considered technically qualified.

(d) **M/S ANJAN KUMAR GHOSH**

On scrutiny it is observed that M/S ANJAN KUMAR GHOSH has submitted all the relevant documents in support of their MSME registration, detail Audited balance sheet, solvency certificate, experience in similar works, similar work completion certificate etc. Therefore, the firm may be considered technically qualified.

(e) **M/s SIM COMPANY**

On scrutiny it is observed that M/s SIM COMPANY submitted solvency certificate more than the prescribed period i.e beyond 6 months Therefore, the firm has not technically qualified.

(f) **M/s SP ENGINEERING**

On scrutiny it is observed that M/s SP ENGINEERING has not submitted Successful work done certificate of similar nature, Details of EPF & ESI, Audited balance sheets etc. Therefore, the firm has not technically qualified.

(g) **M/S LEFT BANK CONSTRUCTION**

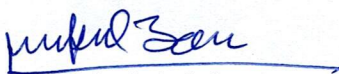
On scrutiny it is observed that M/S LEFT BANK CONSTRUCTION submitted MSME certificate UDYAM-WB-11-0016452 which is not register for Mechanical equipments/ vessel related works, Documents of Authority for signing of the tender has not submitted experience of similar nature works has not submitted. Therefore, the firm has not technically qualified.

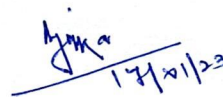
(h) **M/s Manoj Kumar**

On scrutiny it is observed that M/s Manoj Kumar has submitted all the relevant documents in support of their MSME registration, detail Audited balance sheet, solvency certificate, experience in similar works, similar work completion certificate etc. The firm may be considered technically qualified.
