

Recommendation of Tender Evaluation Committee (TEC) on evaluation of online technical bids for "Providing Barbed wire fencing, gates and security huts at MMT Sahibganj 2023-24".

Technical bids for the Tender for "Providing Barbed wire fencing, gates and security huts at MMT Sahibganj 2023-24" was published on 11.10.2023 by RO, IWAI, Kolkata. The estimated cost was Rs 181.86 lakhs plus GST. The bid security was kept as Rs 3.64 lakhs.

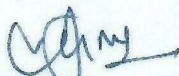
