2. M/s Das Consultancy & Agency Service, Guwahati

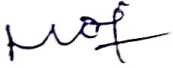
A comparative statement has been prepared and enclosed herewith as Annex-1.

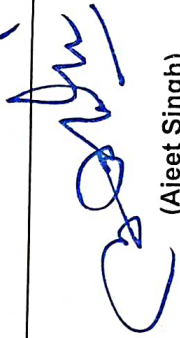
