(4) Observation of TEC:

(a) M/S A C ROY SHIPBUILDERS PRIVATE LIMITED

On scrutiny it is observed that M/s A C ROY SHIPBUILDERS PRIVATE LIMITED has submitted all the relevant documents in support of their MSME registration, detail Audited balance sheet, solvency certificate, experience in similar works, similar work completion certificate etc. The firm may be considered technically qualified. Accordingly financial bid was opened on dated 24.1.2023. Based on Comparative statement, M/S A C ROY SHIPBUILDERS PRIVATE LIMITED (L-1) has quoted Rs. 29,89,357.00 which is higher (+9.86%) than estimated cost.

(b) M/S MILAN MARINE SERVICE

On scrutiny it is observed that M/S MILAN MARINE SERVICE has submitted all the relevant documents in support of their MSME registration, detail Audited balance sheet, solvency certificate, experience in similar works, similar work completion certificate etc. The firm may be considered technically qualified. Accordingly financial bid was opened on dated 24.1.2023. Based on Comparative statement, M/S MILAN MARINE SERVICE (L-3) has quoted Rs. 31,29,219.00 which is higher (+15.00%) than estimated cost.

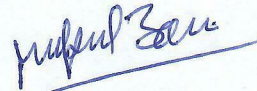
(c) **M/S RUPNARAYAN MARINE WORKS**

On scrutiny it is observed that M/S RUPNARAYAN MARINE WORKS has submitted all the relevant documents in support of their MSME registration, detail Audited balance sheet, solvency certificate, experience in similar works, similar work completion certificate etc. The firm may be considered technically qualified. Accordingly financial bid was opened on dated 24.1.2023. Based on Comparative statement, M/S RUPNARAYAN MARINE WORKS (L-2) has quoted Rs. 30,59,832.00 which is higher (+12.45%) than estimated cost.

(5) **Recommendation:**

R.O. Kolkata TEC, scrutinized the bids of three(3) technically qualified bidder and observed that M/s A C ROY SHIPBUILDERS PRIVATE LIMITED is L-1 bidder has quoted Rs. 29,89,357.00/- plus GST and cost of spare on actual plus 10% basis which is higher (+9.86%) than estimated cost Rs.27,21,060.00/- .In this regards a letter was issued to M/s A C ROY SHIPBUILDERS PRIVATE LIMITED for negotiation of rates dated 04.12.2023 and in reply a letter has been received vide diary no. 3849 dated 12.12.2023 in which he has provide the negotiation rate of Rs. 28,53,304.51 say 28,53,304.00/- which is higher (+) 4.86% then the estimated cost.

TEC recommends that work may be awarded to L-1 bidder i.e. M/s A C ROY SHIPBUILDERS PRIVATE LIMITED at the negotiated price of Rs. 28,53,304.00/- (excluding GST) plus cost of spare on actual +10% basis with approval of the approval of Competent Authority.
