Kindly refer to e-tender no. 2023_IWAI_780948_2 for ANNUAL AFLOAT REPAIR OF W.B GULMOHAR FOR THE YEAR 2023-24, we are pleased to place a work order to M/s. Sabita Udyog, Howrah at a total cost of Rs. 2,76,555.00/- (Rupees Two Lakh Seventy Six Thousand Five Hundred Fifty Five wherein Labour charges Rs. 1,56,555/- Excluding GST and cost of spares Rs 1,20,000 (tentative) and excluding of GST as applicable, as per enclosed bill of quantity in accordance with the tender terms & conditions. Cost of spares on actual + 10 % basis to be paid subject to spares fitted and supplied within estimated cost. Incremental spare cost to be approved by Competent Authority.

The total cost of work shall be Rs. 2,76,555.00/- and excluding of GST as applicable, as per item wise rate mentioned in the enclosed BOQ subject to variation of quantity of work actually executed and certified by the EIC. The above-mentioned total cost is inclusive of taxes, duties and other levies etc, excluding GST as specified in tender. The payment shall be made on submission of bill after certification of the E.I.C for the actual quantity executed. The work shall be completed within 30 (Thirty) days from the date of placement of vessel in the yard. As per tender Technical and special conditions no.11 all statutory survey by surveyor of IWT, State Government shall be arranged by the contractor on behalf of the Authority and survey fees and third party insurance and any other endorsement/documentation as claimed by the IWT surveyor will only reimbursed by Authority. If any additional work is required to be carried out, completion period shall be extended accordingly.

You are requested to deposit an amount Rs. 13,828/- (Rupees Thirteen Thousand Eight Hundred Twenty Eight only) i.e., the 5% of the contract value of the work order either in the form of RTGS/ NEFT through scheduled / nationalized banks in the favour of "Inland Waterways Authority of India Fund" payable at Kolkata (or) in the form of irrevocable bank guarantee of any scheduled bank towards performance Guarantee within 15 days of the issue of this work order as per terms & conditions of the tender document. In addition to the above, a security deposit equivalent to 5% of the contract value (i.e. Rs. 13,828/- (Rupees Thirteen Thousand Eight Hundred Twenty Eight only) will be deducted from your 1st RA bills as per Clause 4 of the General Conditions of Contract.

In case of delay in completion of the repair work of the vessel and delivery thereafter, liquidated damages as per the Clause no. 35 will be applicable @ 1.5% per month of delay for delay of work to be computed on per day basis subject to a maximum 10% on the total value of the contract.

A list of the additional work which is considered necessary as per recommendation of the EIC and or those which are directed during the course of repairs for satisfactory completion of repairs and subsequent commissioning of vessel should be prepared jointly by EIC and contractor. Thereafter, contractor shall furnish quotation for those items of work for which rate would be derived from the agreement or afresh as the case may be in force along with extra time required for completion of all the additional work. The rate for the additional work shall be approved as provided in clause No. 12 of Technical & Special Conditions of contract and clause no. 16 of the General Condition of contract for execution.

The work executed all items of work attended and spare etc supplied by the contractor shall have Guarantee period of minimum 6 months or manufacturer warrantee whichever is more from the date of delivery of the vessel after repair.

An agreement shall be entered between this Authority and Firm in the approved format within ten days from the date of receipt of work order. You are requested to attend this office with 2 non-Judicial stamp papers of Rs 100/- each for signing of contract agreement and integrity.

It is requested to convey your acceptance for this work order by signing the copy of this letter immediately.
