(a) M/S MILAN MARINE SERVICE

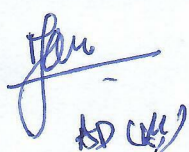
On scrutiny after opening of the financial bid of technical qualified bidder M/S MILAN MARINE SERVICE based on the comparative statement it is observed that M/S MILAN MARINE SERVICE has (L-2) has quoted Rs. 31,09,485.00 /- which is higher (+15.00%) then the estimated cost.

(b) M/S PATRA SHIPPING PRIVATE LIMITED

On scrutiny after opening of the financial bid of technical qualified bidder M/S PATRA SHIPPING PRIVATE LIMITED based on the comparative statement it is observed that M/S PATRA SHIPPING PRIVATE LIMITED has (L-1) has quoted Rs. 29,74,290.00 /- which is higher (+10.00%) then the estimated cost.

(5) TEC Recommendation:

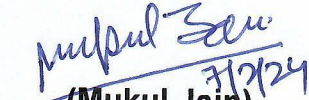
R.O. Kolkata TEC, scrutinized the bids of two(2) technically qualified bidder and observed that M/s PATRA SHIPPING PRIVATE LIMITED is L-1 bidder has quoted Rs. 29,74,290.00/- plus GST and cost of spare on actual plus 10% basis which is higher (+10.00%) then estimated cost Rs.27,03,900.00/- .In this regards a letter was issued to M/s PATRA SHIPPING PRIVATE LIMITED for negotiation of rates dated 05.02.2024 and in reply a letter has been received vide mail dated 06.02.2024 in which he has provide the negotiation rate of Rs. 28,33,687.20/- say Rs. 28,33,687.00/- which is higher (+) 4.80% then the estimated cost.
