(4) Observation of TEC:

(a) M/S INLAND MARINE ENTERPRISE

On scrutiny it is observed that M/S INLAND MARINE ENTERPRISE has not submitted many relevant documents likes Audit balance sheet, work completion certificate, Original tender document duly stamped and signed by the authorized signatory of the bidder etc. The firm may not be considered for technical qualification.

(b) M/S MILAN MARINE SERVICE

On scrutiny it is observed that M/S MILAN MARINE SERVICE has submitted all the relevant documents in support of their MSME registration, detail Audited balance sheet, solvency certificate, experience in similar works, similar work completion certificate etc. The firm may be considered for technically qualification.

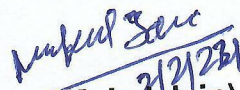
(c) **M/S PATRA SHIPPING PRIVATE LIMITED**

On scrutiny it is observed that M/S PATRA SHIPPING PRIVATE LIMITED has submitted all the relevant documents except i.) Banned or de-listed declaration, ii.) Authority for signing of the tender, iii.) Declaration of No- alteration has been made in any form in downloaded tender document is to be closed with tender by bidder for downloaded tenders.

As per TEC opinion the above shortfall documents was asked to M/S PATRA SHIPPING PRIVATE LIMITED on dated 27.01.2024 through online e-procurement site. Accordingly the shortfall documents have been submitted by M/S PATRA SHIPPING PRIVATE LIMITED on dated 02.02.2024. Therefore the firm may be considered for technical qualification.

(5) **TEC Recommendation:**

TEC recommended that as 02 bidders has qualified technically. We may open the financial bid of (02) firm's i.e. M/s Patra Shipping Private Ltd , M/s Milan Marine Services.
