3. You have accepted Shri G.R. Agarwal, Retired Additional Member Electrical Railway Board to be appointed as the Adjudicator for the subject work.
4. You are requested to submit Insurance Policy as per GCC Clause 13.1.
5. You are hereby requested to furnish performance security of INR 2,01,07,000 (Rupees Two Crores One Lakhs Seven Thousand Only) in terms of clause 50.1 of General Condition of Contract (GCC) and Particular condition of contract within 28 days of the receipts of this Letter of acceptance notification of award as specified in Clause 50.1 of ITB and shall valid up to 28 days beyond the date of completion of performance obligation including warranty obligation, failing which the action as stated in clause 50.1 of ITB can be taken.
6. Following recommendation made by evaluation committee have been accepted by the competent authority while finalizing the bid:

"All items mentioned in enclosed Annexure (23 items), be given to field executives in charge of the work and shall ensure that these high rates items identified in Annexure shall be kept under close watch and any positive variation in these items be avoidable to the extent possible and if essentially required to be done, the same shall be only with finance concurrence and approval of accepting authority".
