4. You are requested to submit insurance policy as per GCC 13.1 and shall cover from start date to the end of the defect liability period.
5. You are hereby requested to furnish Performance Security of **Rs. 82,40,756/- (Rupees Eighty-Two Lakh Forty Thousand Seven Hundred and Fifty-Six only)** in terms of clause 50.1 of General Condition of Contract (GCC) and Particular Condition of Contract (PCC) within 28 days of receipt of the letter of acceptance notification of award as specified in clause 50.1 of ITB and shall be valid up to 28 days beyond the date of completion of performance obligation including warranty obligation, failing which the action as stated in clause 50.1 of ITB can be taken.
