As per our report dated 30.11.2023 and email dated 11.12.2023, the bidder M/s STUP CONSULTANTS Pvt. Ltd. in JV with M/s Sowil Limited in association with M/s Jaiman Construction and Consultants LLP has been declared as Non-Responsive due to JV member M/s Sowil Ltd. has been debarred for a period of 1 year by NHAI vide letter no. NHAI/HQ/MP/2023/Sowil/Debarment (e-file 201801) dated 01.09.2023.

In Ministry's circular dated 04.01.2022, File No.- RW/NH-33044/76/2021-S&R (P&B) stated in Amended Provision at 9.1 that “Upon declaration of non-performer, the AE/IE/CSC/PMC will not be able to participate in any bid for National Highways projects with MoRTH or its executing agencies till such time the debarment persists or the AE/IE/CSC/PMC is removed from list of non-performers. In bidding for a particular project, bids from only such firms, should be considered for placement of contract, **which are neither debarred on the date of opening of tender nor debarred on the date of issue of Letter of Acceptance (LoA).**”

9.2 In case, any debarred/declared non-performer firm submits the bid, the same will be ignored. In case such firm is lowest (L-1), next lowest firm shall be considered as L-1.

However, as the JV member M/s Sowil Ltd. has not been debarred at the time of opening of tender i.e., 12.05.2023. Further, LoA has not been issued for the subject project as the Bidding are under process, accordingly, in case, the above-mentioned Bidder/JV is a successful bidder (L1) and the debarment also persists on the day of issue of LoA, the next Lower Firm shall be considered as L-1. Therefore based on the above facts and discussion with the authority and after considering the representation submitted by the bidder vide letter dated 14.12.2023 regarding the request of Technical Evaluation of Bid Proposal and consideration of proposal as responsive and opening of financial proposal,

the Bidder has been considered as Technically Responsive and the representation submit by the bidder dated 25.09.2023 mentioned in above table has been re-evaluated (**detailed attached as Annexure- “A”**).

Further, we have also received the representation from one of the bidder namely M/s MSV INTERNATIONAL INC. in association with M/s TTL Engineering Pvt. Ltd. from the authority vide email dated 19.12.2023 details are as follows:
