

Minutes of the Meeting Held on 15/05/2023 at 1500 hrs to finalize the Financial Evaluation of bid received for IRQP work of Road from Km 0.00 to 45.00 on NH 87 Ext (New NH 109) on EPC mode under Annual plan 2022-23 in the state of Uttarakhand.

- 1- The work " IRQP work of Road from Km 0.00 to 45.00 on NH 87 Ext (New NH 109) on EPC mode under Annual plan 2022-23 in the state of Uttarakhand" was sanctioned vide RO/UK/AnnualPlan/2022-23/Haldwani/02, (C. No. 213703) Dt.28.10.2022 for Rs 49.23 Cr (Job No: NH-87E (New 109)AP/ UK/2022-23-628).
- 2- The bid for above work was invited through E-tendering by Superintending Engineer, N.H. Circle, PWD, Haldwani vide letter No. 702/12M-NH/2023, Dt. 27-02-2023. The estimated project cost for the work is ₹ 38.60 Crore (excluding GST).
- 3- The meeting of evaluation committee chaired by Chief Engineer, NH, PWD, Dehradun on dt. -05-2023. In the presence of following officers:-

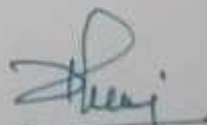

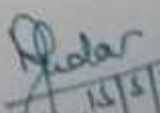
- 5- Committee found that quoted bid price of ₹ 30,60,98,000.00 (Rs. Thirty Crore Sixty Lacs Ninety Eight Thousand Only) by M/s JRD Infratech Private Limited is lowest and 20.70 % below from the estimated cost. Thus the committee declared that M/s JRD Infratech Private Limited as the selected bidder.
- 6- The committed directed to Superintending Engineer, N.H. Circle, PWD, Haldwani to issue LOA in the name of M/s JRD Infratech Private Limited and do the further action for contract formation. It is also directed to take Additional performance security as the bid is 20.70 % below.
