1. The 3rd Call of the Tender was done with Bid due date as 15-03-2023. The Technical bids were opened on 16-03-2023 in presence of the Committee. On opening of the Technical Bid of the Tender, following bidders had submitted their bids as on bid due date. The details of the bidders are as under.

2. The down loaded bids were examined by the Committee and it is noted that the all 2 (Two) bidders had submitted their bids via both BIMS Portal and CPPP portal. Therefore, the Committee decided to open the Technical Bid of all the bidders for evaluation.

3. The Technical Bid of all 2 (Two) bidders were evaluated by the State Level Evaluation Committee and all the 2 (Two) bidders are found to be Technically Responsive vide above referred MoM dtd. 06-04-2023.

4. In view of above, as per Clause 2.19, 3.1.9 & 3.2 of the R.F.P, the **Financial Bids** of above mentioned Technically Responsive 2 (Two) bidders shall be opened after uploading the outcome of Technical Proposal evaluation online.

Minutes of meeting of Evaluation Committee is held on 06-04-2023 in the Chamber of Chief Engineer (NH) & Addl. Secy., Roads & Building dept. Block No.14, 1st floor, New Sachivalaya, Gandhinagar for the opening and evaluation of the Technical Bids of the bidders for the work mentioned above. The following Committee members were present.

2. At the outset, the Chief Engineer (NH) & Addl. Secy. welcomed the participants. The committee was appraised that the Technical, Administrative and Financial sanction to the instant work amounting to Rs.26.07 Crore was issued vide Ministry's letter No. RW/GNR/AP 2021-22/IRQP/NH-927K/North-II C.no. 199988 Dtd. 27-09-2022.

3. It was also apprised to the committee that the 1st Call of tender was done with bid due date as 09-11-2022 and extended in time to time up to 16-11-2022 up to 12.00 Hours. The bids were opened on 17-11-2022 in presence of the Committee. Only 1 (One) bidder had submitted their bids as on bid due date. Being it's a single tender, the committee decided to Re-invite the tender once again.

4. The 2nd Call of tender was done with bid due date as 29-12-2022 and the Technical bids were opened on 30-12-2022 in presence of the Committee. 3 (Three) bidders had submitted their bids as on bid due date. The bids were evaluated by the committee and all bidders were found to be technically responsive. Hence the Financial Bid for the work was opened on 23-01-2023, the L-1 bidder M/s. Amber Builders quoted 19.50% above the cost put to tender. Evaluation Committee its minutes of meeting dtd. 31-01-2023 states that directed Member Secretary to obtain justification for high quoted rates from L-1 bidder and examine the same. After verification by Member Secretary, the justification for high quoted tender rates may be placed before the Evaluation Committee in the next meeting. The Justification submitted by the L-1 bidder for high quoted bid rates is not accepted by the Committee and decided to re-invite the tender once again.

5. The 3rd Call of the tender is invited on 01-03-2023 with bid due date is 15-03-2023. The Technical Bid for the 3rd Call tender is opened on 16-03-2023, following 2 (Two) bidders had submitted their bid as on bid due date on e-procure portal and as well as on BIMS Portal. Details of the bidders are as under.

6. The downloaded bids was examined by the Committee and both bidders had submitted their Bids via both BIMS Portal and CPP Portal. Hence Evaluation Committee decided to opened the Technical documents of both the bidders for Evaluation.

7. The Committee noted that automatic Bid Evaluation through BIMS is not working. The EE (NH) appraised that on enquiry from the BIMS Helpdesk, It was conveyed that "At present Technical Evaluation is not being done through Portal". Therefore, The Committee decided to download the Technical bid of the all the bidders from the BIMS portal for evaluation of bids in the conventional manner.

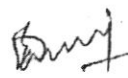

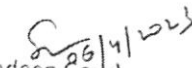
