Estimate Amount: Rs. 9000.62 Lakhs

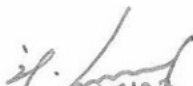

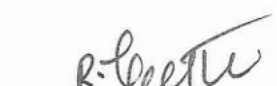
1. The chairman welcomed the committee members.
2. The tenders received through online for the above work were opened by the Evaluation Committee on 03.05.2023. The Evaluation Committee vide minutes dated 02.06.2023 has sought clarifications from the bidder M/s.RPP Infra Projects Limited. The technical bids were finally evaluated by the committee on 12.06.2023. After Evaluation the Committee decided to declare the technical bids of 1) M/s.RPP Infra Projects Limited and 2) M/s.CDR & Co Constructions as "Responsive".
3. The committee had directed the Superintending Engineer (NH), Salem to upload the results of technical evaluation in CPPP e - procurement portal. The Superintending Engineer (NH), Salem informed the Committee that the technical evaluation was uploaded and the date of opening of financial bids was fixed as 05.07.2023. Subsequently, the date of opening of financial bids was postponed to 06.07.2023 due to administrative reasons. Superintending Engineer (NH), Salem informed the committee that no representation has been received from any of the bidders.

As per clause 2.2.2.1 of RFP, Superintending Engineer (NH), Salem has sought updated value of "B" of the above responsive bidders vide Lr No. TRP 96/2023-24/DO/Dated.27.06.2023 requesting to furnish reply on or before 04.07.2023, 03.00 PM. Superintending Engineer (NH), Salem informed that both the bidders have submitted the updated value of "B" within the stipulated time.

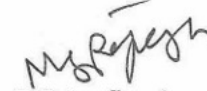
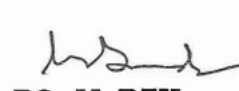
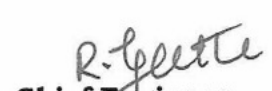
5. The Financial bids of the above responsive bidders were opened by the Committee on 06.07.2023 as notified. The Committee evaluated the financial bids of the bidders and the results are tabulated.

6. After evaluation of the Financial bids, the Committee found that the bid of **M/s.CDR & Co Constructions** amounting to **Rs.49,95,00,009/- (Rupees Forty Nine Crore Ninety Five Lakh and Nine only) (Exclusive of GST)** working out to **4.82% above** the estimated cost of work (SOR 2021-22) put to tender is the lowest. Accordingly, the Committee recommended the lowest bid of **M/s.CDR & Co Constructions** amounting to **Rs.49,95,00,009/- (Rupees Forty Nine Crore Ninety Five Lakh and Nine only) (Exclusive of GST)** for seeking approval of the Competent Accepting Authority, after getting revalidation from the Ministry.
