

Minutes of Meeting of Technical Evaluation Committee held on 30.06.2023 for examination of Technical Bids for the work of “Construction of retaining wall at Km 98.150 to protect the embankment and Construction of widening of Pipe Culvert at Km 76.300, Km 77.800, Km 85.450, Km 87.900, Km 88.320, 88.360, Km 89.950 and Km 109.900 and diversion of road due to damaged carriageway at Km 77.750 and Km 90.050 and providing sand bags for scouring portion of Koyanadu bridge abutment portion of Sampaje Ghat of NH-275 Bantwal-Bangalore section under State Head”

The State Government of Karnataka in the letter dated: 07-03-2023 has communicated the grant under head of account 5054-03-337-0-17-154 for the year 2022-23 for an amount of Rs.150.00 lakhs.

The estimate has been technically sanctioned by the Chief Engineer, National Highways, Bangalore vide CER No. 74/2022-23 dtd 13.03.2023 for an amount of Rs.150.00 Lakhs.

The Draft Tender Schedule as per KW4 has been prepared and submitted with a request to communicate approval and in view of the urgency, it was requested to accord permission to invite short term tenders allowing the time limit of 7 days as against 15 days as per para 17(2) of KTPP act.

Accordingly, the Superintending Engineer, National Highway Circle, Bengaluru accorded approval to DTS vide letter dated: 14-03-2023 and also accorded permission to invite short term vide letter dated: 13-03-2023.

The Short-Term Tenders have been invited by the Executive Engineer, NH Division, Mangaluru in KW-4 format (Two cover system) in e- portal <https://eprocure.gov.in> vide Executive Engineer office tender notification No. EE/NHD/MNG/AE2/Appendix-E/NIT/2022-23/08 Dated: 14.03.2023. In response, two bidders have participated in the tender and submitted their bids. However, only one bidder has technically qualified.

Technical Evaluation Committee meeting held on 06.04.2023 directed to re-invite the short term tender allowing 8 days time after election code of conduct.
