2. Now, in supersession of earlier declaration of result of Technical Evaluation published on CPPP website <https://eprocure.gov.in/eprocure/app> on 26.10.2023 vide this office memo no.868/W-309 dated 26.10.2023, stands modified and Declaration of **Revised Result** of Technical Evaluation is notified herein under.

A. Technical Bid of following 9 (Nine) bidders are declared as "**technically Non-Responsive**" by Evaluation Committee:

I. **DINESHCHANDRA R. AGRAWAL INFRACON PVT.LTD**

Submitted Rs. 10,000/- only as Cost of Bid instead of requisite amount of Rs. 30,000/- only.

Hence the technical bid of the Bidder is declared as **Non-Responsive**.

II. **BENGAL TRADING COMPANY**

Submitted Rs. 10,000/- only as Cost of Bid instead of requisite amount of Rs. 30,000/- only.

Hence the technical bid of the Bidder is declared as **Non-Responsive**.

III. **ABCI INFRASTRUCTURES PVT LTD**

Submitted Rs. 10,000/- only as Cost of Bid instead of requisite amount of Rs. 30,000/- only.

Hence the technical bid of the Bidder is declared as **Non-Responsive**.

IV. **M/S MOHAN LAL JAIN**

Not submitted the documents physically as mentioned under Clause no. 2.11.2 of the RFP (with and including its Addenda/Corrigendum).

Hence the technical bid of the Bidder is declared as **Non-Responsive**.

V. SPICA PROJECTS AND INFRASTRUCTURES PVT LTD

Not submitted the documents physically as mentioned under Clause no. 2.11.2 of the RFP (with and including its Addenda/Corrigendum).

Hence the technical bid of the Bidder is declared as **Non-Responsive**.

VI. ANSAL HIGHWAY INFRA TECH PRIVATE LIMITED

Not submitted the documents physically as mentioned under Clause no. 2.11.2 of the RFP (with and including its Addenda/Corrigendum).

Hence the technical bid of the Bidder is declared as **Non-Responsive**.

VII. S. S. CIVIL CONSTRUCTION PVT. LTD

Threshold Technical Capacity (Rs. 227.89 Crore) is less than minimum requirement (Rs. 277.93 crore) as per RFP (with and including its Addenda/Corrigendum).

Hence the technical bid of the Bidder is declared as **Non-Responsive**.

VIII. SBCC & AC JV

Threshold Technical Capacity (Rs. 50.32 crore) of the other member (AC) of JV is less than minimum requirement (Rs. 55.59 Crore) as per RFP (with and including its Addenda/Corrigendum).

Hence the technical bid of the Bidder is declared as **Non-Responsive**.

IX. OSS & JSC BUER JV

(a) OSS Construction Pvt. Ltd. the Lead Member of JV has submitted two works [Project Code 'A' (Phase-I/Package-II, Ghosikhurd National Project) & Project Code 'B' (Phase-I/Package-III, Ghosikhurd National Project)] under eligible projects implemented for a private party/contractor. The bidder was asked to submit the documentary evidence in support of these two works from Authority. However, no approved copy of subcontracting/Agreement issued by the Authority (NBCC(INDIA)Ltd. in this case) is submitted for these two works.

(b) Whereas, the bidder has submitted sub-contracting document of Phase-I/Package-I, Ghosikhurd National Project which is not under list of eligible project claimed by the bidder. Further, in the submitted subcontracting agreement, it comes to notice that subcontracting agreement of main contractor is with OSS property Development Services Pvt. Ltd., not with OSS Construction Pvt. Ltd.

(c) Further, bidder has also submitted a letter (which was submitted by main contractor to authority) in which bidder is mentioned as Vendor(civil) not as a Sub-Contractor by the Main Contractor.

(d) As per Clause 2.2.2.6 (ii) of RFP, the Bidder/Lead member of JV has failed to submit a certificate on account of payment received details of eligible projects duly certified by

Engineer-in-charge/Independent Engineer/Authority's Engineer. No evidentiary documents are submitted showing payment received by OSS CONSTRUCTION PRIVATE LIMITED for the eligible project (Project Code 'A' & 'B') from the client i.e. NBCC(INDIA)Ltd.

Threshold Technical Capacity of Lead member (OSS) is worked out excluding the projects (Project Code 'A' & 'B') and found Rs. 67.22 Crore which is less than the minimum requirement (Rs. 166.75 crore) as per RFP (with and including its Addenda/Corrigendum).

Hence the technical bid of the Bidder is declared as **Non-Responsive**.

B. Further, Technical Bid of the following 1(One) bidder is "**Rejected**" & the Bidder is declared as **Disqualified** by the Technical Evaluation Committee:

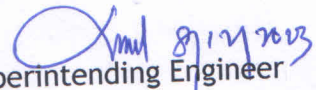
I. AARPEE INFRAPROJECTS PVT. LTD

The bidder has clearly made material misrepresentation/given materially incorrect & false information/suppression of fact and thus the bid is **Rejected** and the Bidder is declared as **Disqualified** pursuant to clause 2.6.2(a), 2.6.3 and clause 4.1, 4.2 & fraudulent practice as per clause 4.3(b) of section 4 of RFP. Moreover, threshold technical capacity is reassessed and found to be (Rs. 269.99 Cr.) less than the minimum requirement (Rs. 277.93 Cr.)

C. Finally, Technical Bid of the following 10(Ten) bidders are declared as "**Responsive & Technically Qualified**" by the Evaluation Committee.

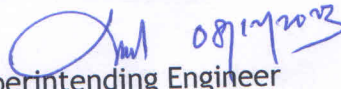
