

Minutes of the 2nd meeting of the Evaluation Committee held on 22.12.2023 for Evaluation of Technical bids for the work of "Slope Protection and Landslide Mitigation at Vulnerable Locations (km 6.20 to km 6.93, km 7.10 to km 7.25, km 21.40 to km 21.65, km 22.20 to km 22.300) within Sevoke-Rangpo Section of NH-10 (old NH-31A) in the district of Kalimpong in West Bengal during FY 2022-23 on EPC Mode (Job No.010/WB/2022-23/519)". [eTender ID : 2023_MoRTH_748031_1]

Sanctioned Cost : Rs.73.32 crore and Cost put to tender: Rs.65.08 crore

1. In pursuance of sanction of the work, on-line bid was invited by the Superintending Engineer, NH Circle No.III, P.W. (Roads) Directorate on behalf of Chief Engineer, NH Wing through the e-tendering portal <https://eprocure.gov.in/eprocure/app> for the subject work under e-RFP No.30 of 2022-23 of Superintending Engineer, NH Circle-III dated 31.03.2023. After receiving of the Bid Security and other original bid documents physically within the scheduled date and time, Technical Bid was opened on e-procurement portal on 07.09.2023 after 11:00 hrs at the office of the SE, NH Circle-III and it was found that following 5(five) bidders have participated in the bid.

- (i) S. S. Civil Construction Pvt. Ltd.
- (ii) Bharat Constructions (India) Private Limited
- (iii) Pioneer Foundation Engineers Pvt. Ltd.
- (iv) NG Projects Limited
- (v) H.M.B.S. Textiles Pvt. Ltd..

2. The 1st meeting for evaluation of Technical bids for the above mentioned work was held on 01.12.2023 and the following bidders were found to be responsive and technically qualified as per minutes of the meeting dated 01.12.2023.

- (i) Bharat Constructions (India) Private Limited
- (ii) Pioneer Foundation Engineers Pvt. Ltd.

3. Therefore, as per provision laid down under clause 2.19 of RFP, Technical Bid Evaluation Summary comprising of the list of Technically Responsive bidders and the names of Technically non-responsive bidders along with reasons for their non-responsiveness were uploaded on the CPPP web portal on 04.12.2023 with the intimation that the Financial Bid of all the responsive bidders as mentioned in para-2 above is scheduled to be opened (online) on 11.12.2023 at 11:00 hrs.

4. The Superintending Engineer, NH Circle-III informed the members of the Evaluation Committee that a representation has been received from NG projects Limited through email dated 07.12.2023 against the result of BID evaluation for the above mentioned work and also with the work namely "Slope Protection and Landslide Mitigation at 8 Vulnerable Locations (km 3.75 to km 3.90 km 8.21 to km 8.36, km 11.393 to km 11.628, km 33.35 to km 33.70, km 38.93 to 39.220, to km 44.903 to km 45.078, km 48.490 to km 48.560 and km 49.310 to km 49.570) within Sevoke-Rangpo Section of NH-10 (old NH-31A) in the district of Kalimpong in West Bengal during FY 2022-23 on EPC Mode (Job No.010/WB/2022-23/520)" published vide eTender ID : 2023_MoRTH_748011_1.

5. The representation has been examined by the Evaluation Committee and following facts are found:

a. In this connection it is to mention that the modifications in Clause no. 2.2.2.2(ii), 2.2.2.2 (iii) and 2.2.2.5 (ii)(IV) were made in RFP in respect of above two works (Job No. 520 & 519) with the approval of DG(RD) &SS, MoRTH.







b. Para wise issues raised by the bidder 'NG Projects Limited' & comments are as under:

2.	The reason for disqualification of NG Projects Ltd by the Evaluation Committee:	
2.1	Cost of bid submitted vide UTR/RN No. N241232615597281 dated 29.08.2023 for Rs 10,000 in both soft & hard copies which is the same for Job No.519. So Bid may be evaluated for only one project which is opened first i.e. e-RFP No.28 of 2022-23 of Superintending Engineer, NH Circle-III dated 31.03.2023.	The Bidder himself has admitted that "the same Soft copy of the Tender Fees was uploaded for both tenders wrongly".
2.2	No Similar work (slope stabilization / landslide mitigation in hilly/mountainous region) of 20% Estimated Project Cost found completed from the eligible project in category 1 and / or Category 3 specified in Clause 2.2.2.5 in the last 10 (ten) financial years preceding the bid due date by the bidder.	i. As per the RFP Cl.2.2.2.2 (ii), the bidder must have completed at least one similar work (slope stabilization / landslide mitigation in hilly/ mountainous region) of 20% Estimated Project Cost from the Eligible Projects in Category 1 and/or Category 3 specified in Clause 2.2.2.5 in the last 10 (Ten) financial years preceding the Bid Due Date. As per Clause 2.2.2.5(iii) (IV)(vii) of RFP, in case bidder has executed any slope stabilization / landslide mitigation involved in Projects in Roads/ Railways/ Hydro electricity /Airport in hilly / mountainous region, the value of such component shall be duly certified by the Engineer-in- Charge / Authority's Engineer / Independent Engineer. ii. Further the Bidder should have at least two additional experience out of three as defined in Cl.2.2.2.2 (i) (a), (b) & (c) of RFP. In case, the Bidder does not have additional experience stated above, the Bidder may enter into signing of Memorandum of Understanding (MoU) with a single Specialized System Provider (SSP) as per Cl.2.2.2.2 (i)(f) and SSP needs to meet any of two of above three additional criteria. iii. The bidder can sign MOU with SSP only for demonstrating the additional experience and not for 20% similar nature of work. In both the tenders, the bidder did not claim to have completed any similar work of slope

		stabilization / landslide mitigation in hilly/ mountainous region) of 20% Estimated Project as per CI.2.2.2.2 (ii) of RFP. Accordingly, the Technical bid of the bidder "NG Projects" has been declared non-responsive in both the projects.
3.	The registration of Pioneer Foundation Engineers Pvt. Limited from Government of Maharashtra is Grade IV whose capacity is limited to only 1.5 Cr which has been overlooked and is now being awarded an 89cr + 65 cr. work.	In the RFP, there is no such clause to make any bidder non-responsive based on grade of registration.

c. It is clear from the above that Technical bids of NG projects Limited for both the projects have been declared non-responsive due to want of adequate working experience on similar nature work (slope stabilization / landslide mitigation in hilly/ mountainous region).

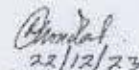

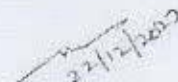
7. Based on the detailed evaluation, the Evaluation Committee recommends following 2(Two) Bidders as "Responsive & Technically Qualified" -

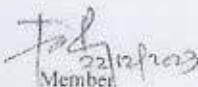
- i) Bharat Constructions (India) Private Limited
- ii) Pioneer Foundation Engineers Pvt. Ltd.

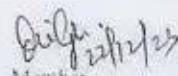

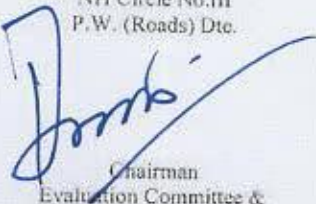

1. SE, N.H. Circle No.III informed that Administrative Approval with Technical and Financial Sanction was accorded by the Ministry vide letter file no. File No. NH-12014.33 2023-RO-KOL dated 29.03.2023 for the subject work on EPC Mode.

2. In pursuance of approval of the work, on-line bid was invited by the Superintending Engineer, N.H. Circle No.III, P.W. (Roads) Directorate on behalf of Chief Engineer, NH Wing through the e-tendering portal <https://eprocure.gov.in/eprocure/app> for the subject work under e-RFP No.30 of 2022-23 of Superintending Engineer, NH Circle-III dated 31.03.2023. After receiving of the Bid Security and other original bid documents physically within the scheduled date and time, Technical Bid was opened on e-procurement portal on 07.09.2023 after 11:00 hrs at the office of the SE, NH Circle-III and it was found that following 5(five) bidders have participated in the bid:

- (i) S. S. Civil Construction Pvt. Ltd.
- (ii) Bharat Constructions (India) Private Limited
- (iii) Pioneer Foundation Engineers Pvt. Ltd.
- (iv) NG Projects Limited
- (v) H.M.B.S. Textiles Pvt. Ltd.

3. As a first step towards evaluation of the Technical Bids, the SE, NH Circle-III has determined the responsiveness of the Technical Bid to the requirements of RFP as per provision under Cl. 3.16 of the RFP and submitted the detailed evaluation sheet before the Evaluation Committee. The detailed evaluation sheet as per the RFP is placed at Annexure-1.

4. The Superintending Engineer, N.H. Circle No.-III informed the Evaluation Committee that out of 5(five) participated bidders as mentioned in para-2, validity of Bid Security of 1(one) bidder namely S. S. Civil Construction Pvt. Ltd. has been found 62 days shortfall in respect of Clause 2.20.1 of RFP and Clause-13 of APPENDIX-II and cost of Bid document has been submitted by another 1(one) bidder namely NG Projects Limited vide UTR/RRN No. N241232615597281 dated 29.08.2023 for Rs.10,000 in both soft & hard copies which is same for Job 520 (8 spots). So Bid may be evaluated for only one project which is opened first i.e. e-RFP No.28 of 2022-23 of Superintending Engineer, NH Circle-III dated 31.03.2023. Therefore, the BID of NG Projects is not considered for evaluation in the present tender. In this context, Superintending Engineer, N.H. Circle No.-III also informed the Evaluation Committee that 1(one) bidder namely H.M.B.S. Textiles Pvt. Ltd. has not submitted the hard-copy of Bid Security & other relevant documents as stated in RFP. Accordingly, the Bid of (1) H.M.B.S. Textiles Pvt. Ltd. and (2) NG Projects Limited are hereby rejected and treated as non-responsive bid.

5. Thus the proposals of the bidder has further been evaluated by the concerned SE, NH Circle III based on the requisite documents furnished to substantiate the Threshold Technical Capacity in accordance to Clauses 2.2.2.2, 2.2.2.5 and 2.2.2.6, Mandatory Technical Experience in accordance to clauses 2.2.2.2, (ii) & (iii), Financial Capacity in accordance to clauses 2.2.2.3, 2.2.2.9(i) & (ii), 2.2.2.8(iii) of RFP respectively and Bid Capacity in accordance to Clause no. 2.2.2.1 of RFP and broad findings are as follows and detailed authenticated Evaluation sheet is annexed:
