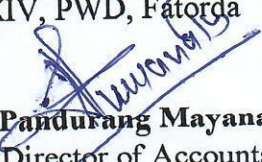
6. The committee recommended that the technical result may be uploaded on e-portal and open financial bid on 08.05.2023 at 11 AM
