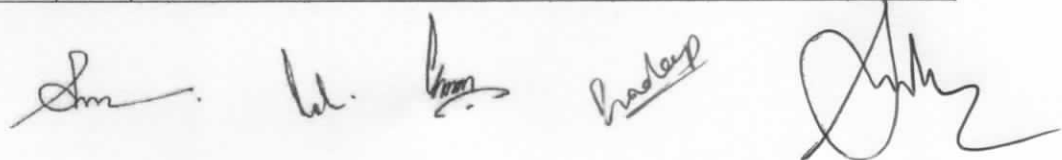

2. The Committee in its meeting held on 21/08/2023 evaluated the Technical Bids of the bidders and the committee uploaded the technical evaluation minute on 22/08/2023. The bidders were given opportunity to respond within 7 days in case they have any objection. Subsequently, one representation was received from bidder namely from AS Construction Company wherein the bidder has requested to review the decision taken by the committee on its meeting on 21/08/2023, it was explained to the bidder that the decision of the committee was as per the provisions set forth in the RFP and the bidder was requested to comply with the reply vide No. CE/Legal Notice/1641/548(A) Dated 29/08/2023. Thereafter, no representation was submitted by the bidders. Accordingly, the committee recommends opening of Financial Bid of the 4 (four) bidders who are Technically Responsive as mentioned below:-

3. Accordingly, the financial Bid of the epic technically responsive bidders was opened on 30/08/2023. The quoted price of the bidders was downloaded and the quoted prices are as tabulated below

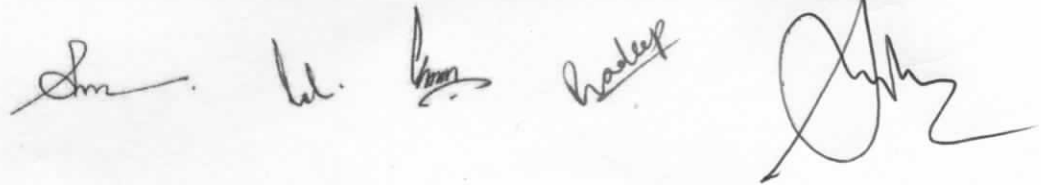

4. The committee examined the financial bid of the 4 (Four) technically qualified bidders on the basis of documents placed before the committee and found the bid price of Maibam Chojot Singh i.e. 24,61,83,468.00 (36.60 % below the amount put to tender) to be the lowest.

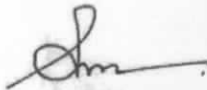
5. The e-portal generated Appendix-1B: Letter comprising the Financial Bid of the 4 (four) bidders were downloaded and enclosed herewith.

6. The committee opined that justification is required for such low bid. Accordingly, the contractor was informed to justify his bid and how he will be able to execute the work at his Bid Price vide no EE/NH-III/Misc/2022-23/100 dated 31/08/2023. The L-1 Bidder submitted his justification vide no. NH-III/Misc/14/2023-24 Dated 04/09/2023. The committee opined that the justification of the bidder is reasonable and decided to proceed with the evaluation.

7. The committee further noted that as per clause 2.21 of the RFP, for a Bid Price of Rs. 24,61,83,468.00 Performance Security 5% of the bid Price ie Rs. 1,23,10,000.00 is to be submitted by the L-1 bidder before signing of the contract agreement for the subject work. And, the committee noted that the bid price is lower than 20% and the committee recommended that an Additional Performance Security amounting to Rs. 3,10,00,000.00 may be taken as per the Ministry Circular No. NH- 37015/01/2022-H(Comp No. 208778) Dated 18.05.2022.



8. After deliberation the committee recommends award of the work "Strengthening of road from Km 459.930 to Km 465.200 of NH-02 under NH division in the state of Manipur for the year 2022-23 on EPC mode" (Job No:02/MN/2022-23/037), to the L-1 bidder, Maibam Chojot Singh, Singjamei Wangma Kshetri Leikai, Imphal-East, Manipur-795010, at his quoted price amounting to Rs. 24,61,83,468.00



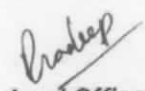

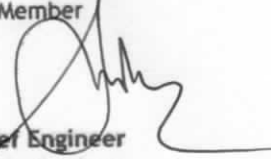
