Minutes of the Meeting of Tender Evaluation Committee held on 21 August, 2023 at 11.00 Hrs for the work, "Strengthening of road from Km 459.930 to Km 465.200 of NH-02 under NH division in the state of Manipur for the year 2022-23 on EPC mode".

Job No:02/MN/2022-23/037

The work under consideration was sanctioned by the Ministry amounting to Rs.41.53 Cr vide Sanction letter No.RW/GHT/Annual Plan/MN/2022-23/01 C. No. 213856 dated 6th January 2023. The estimated civil construction cost of work is Rs. 38.83 Cr. The work is proposed under EPC mode by the State PWD, Manipur as per Ministry's laid down procedures.

2. As per Ministry's Circular no. RW/NH-24035/4/2008-P&M/PIC Vol. II dated 23.02.2018 for works with sanction cost more than Rs. 5.00 crore to Rs. 100 crore, tender may be invited by the state PWD using requisite bidding document and procedure as per ministry's extant guidelines. The composition of the Technical Evaluation Committee is as under:-

3. The tender for the above mentioned work amounting to Rs. 38.83 crores (amount put to tender) was invited by the Chief Engineer PWD, Manipur on 13th April 2023 and opened on 14th July 2023. A total of 5 (Five) bids were received online on CPPP (Central Public Procurement Portal) as well as hard copy of Tender Fee, Bid Security, Power of Attorney etc are physically received from the following bidders:

4. As per Clause 2.2.2.2 (i), for demonstrating of the Threshold Technical Capacity a project is considered as an 'Eligible Project' under Categories 3 and 4 if the work executed is certified by the Engineer-in-charge/Independent Engineer/Authority's Engineer and the amounts (gross) actually received/ work executed, during such 5 (five) financial years preceding the Bid Due Date is more than of Rs.38.83 Cr.

5. As per Clause 2.2.2.2 (ii) for normal highway projects, at least one similar work of cost more than Rs. 7.77 Cr (i.e 20% of estimated project cost) only shall have been completed from the Eligible projects in Category 1 and / or category 3.

6. As per Clause 2.2.2.6 (ii) For a project to qualify as an Eligible Project under Categories 3 and 4, the Bidder should have received payments from its client(s) for construction works executed, fully or partially, or work executed and certified by the Engineer-in-charge/Independent Engineer/Authority's Engineer during the 5 (five) financial years immediately preceding the Bid Due Date, and only the amounts (gross) actually received/ work executed, during such 5 (five) financial years shall qualify for purposes of computing the Experience Score. However, receipts of or work executed amount less than Rs. 1.94 Crores (Rs. One Crores Ninety four Lakhs) shall not be reckoned as receipts for Eligible Projects.

7. Based on the documents placed before the Evaluation Committee and as per criteria mentioned in para 4,5 &6, the committee examined the technical bid of the 5 (five) bidders (The detailed evaluation sheet is enclosed herewith). The following observations have been brought out by the committee:

i. In the case of bidder AS Construction Company, the Bid Capacity of the bidder is comes out to be Rs. 12.54 Cr based on the criteria mentioned in RFP as opposed to the requirement of Rs.38.83 Cr. Accordingly, the bidder is found to be technically non-responsive.

8. In view of the above evaluation and detailed deliberation of the Committee, the Committee recommends the following 4(four) bidder as technically qualified bidders.
