IV The Evaluation Committee evaluated the financial bids during its meeting held on -21-07-2023 (online). It is observed by the evaluation committee that the lowest tendered amount of **Rs. 9,51,00,000.00 /-** (**Rs. Nine Crore Fifty One Lakh Hundred only**) has been quoted by **M/s Vijay Kumar Contractor, Hisar Haryana**, which is **1.3859% Above** on sanctioned civil work cost (based on NH Circle Bikaner BSR April,2019 put to tender).

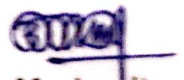
