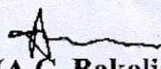
IV. Bids have been evaluated by Evaluation Committee and the following have been observed by the committee.

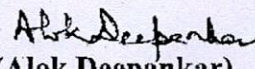

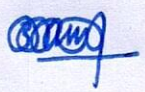
