- (ii) Sunrise Enterprises

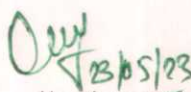

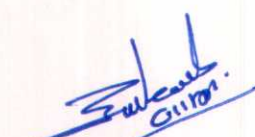

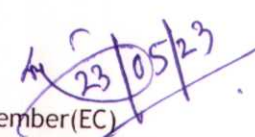

After careful examination of the financial bids of the above-mentioned bidders, the Evaluation Committee observed that the bid price of Rs.2,29,21,313.49/- (Rupees Two Crore Twenty-Nine Lakh Twenty One Thousand Three Hundred Thirteen and Paise Forty Nine) only (including GST) quoted by "Sunrise Enterprises" of Kalijhora Bazar, P.O-Kalijhora, Dist-Darjeeling, West Bengal, India is 4.39 % (approx) above than the estimated amount put to tender is the lowest among two bidders and thus he became L-1 bidder.

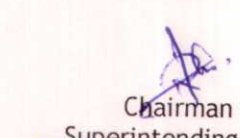
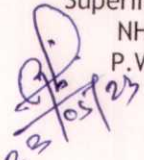

Accordingly, the Committee recommends that the work namely "Restoration works at valley side rain damaged Road Bench at km 22.90, km 22.95, km 23.10 & km 23.70 of NH-10 for the Year 2022-23, under National Highway Division No IX in the District of Kalimpong on item rate mode using SBD. (Job No. NH-10/WB/2022-23/509). (2nd Call)" may be awarded to L-1 bidder, i.e. "Sunrise Enterprises" of Kalijhora Bazar, P.O-Kalijhora, Dist-Darjeeling, West Bengal, India at their quoted price of Rs.2,29,21,313.49/- (Rupees Two Crore Twenty-Nine Lakh Twenty One Thousand Three Hundred Thirteen and Paise Forty Nine) only (including GST) which is about 4.41 % (approx) above the amount put to tender.
