

Minutes of the Meeting of Bid Evaluation Committee held On 5th May, 2023 at 1200 Hrs at the Office of the Chief Engineer PWD (NH) for the work, “Construction of CRSM & Gabion wall and CSRM drain at location 185.700 km on NH-02 (Old NH-39) under PWD(NH), Division-I, Kohima in the state of Nagaland”.

The work under consideration was sanctioned by the Ministry amounting to Rs. 39,38,900.00 vide sanction letter No.RW/GHT/DP/NG(O)2019-20/104/60 dated 20th April, 2023. The estimated civil construction cost of work including GST is Rs. 39,38,900.00.

2. The tender for the above mentioned work amounting to Rs. 39,38,000.00 was invited by the Chief Engineer PWD (NH), Nagaland on 21.04.2023 and opened on 04.05.2023. A total of 2(Two) bids were received online on www.eprocure.gov.in/eprocure/app from the following bidders:

3. Upon verification of the documents submitted physically in accordance with clause 16, the following were observed

5. The validity of Bid Securities submitted by the 2(Two) bidders were examined by the Committee and were found to have valid amount and validity. Furthermore, the confirmations of the Bank Instrument were obtained from respective banks.

6. Based on the documents placed before the Bid Evaluation Committee, the committee examined the technical bid of the 2 (Two) bidders (The detailed evaluation sheet is enclosed herewith). Upon evaluation and detailed deliberation of the Bid Evaluation Committee, the 2 (Two) bidders are found to be the technically qualified.
