

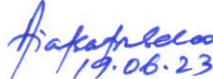

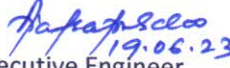
Cancellation of Bid

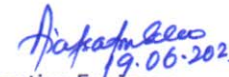

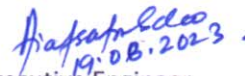
