

Minutes of Meeting of the Evaluation Committee for examination of representations received on result of Technical Evaluation held on 28.02.2024 under the chairmanship of CE NH PWD Bhopal for evaluation of Technical Bids for the work of "Consultancy Services For Authority's Engineer For Supervision of Upgradation and Reconstruction of Shahpura -Dindori section of NH 45 from km. 103.700 (Design) to Km. 164.580 (Design) including 03 Bypasses (Total length 60.88 km) to Two lane with One time improvement of 03 Nos bypassed built-up areas in a total length of 12.341 km in the State of Madhya Pradesh on EPC mode.

[Job no: 45-MP-2021-22-27; Project Cost: Rs. 250.09 Crore (Including GST)]

Earlier, the meeting of Evaluation committee for Evaluation of technical Bids was held on 14.02.2024 & the result of Technical Evaluation was uploaded on e-Procurement portal on 20.02.2024. The bidder was given an opportunity for representation by 26.02.2024, if any. The Evaluation committee examined the representations received up to due date and time from the bidder as under:-

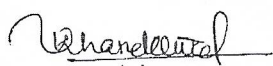
1. The bidder namely M/S Theme Engineering Services Pvt.Ltd in Association with M/s Ishita Info Solutions Pvt.Ltd. Jaipur Email-id-bd@themeengineering.com vide letter no .MORTH/CE/MP/Shahpura-Dindori/9799 dated 24.02.2024 has submitted the representation in respect of marks awarded to Senior pavement Specialist Mr.Verma Vijay Kumar enclosing copy of the Bachelor Degree.

Earlier, based on submission uploaded by the bidder on e-portal, i.e. BE mark sheet only and not the Degree, the committee evaluated and zero mark was given to the Senior Pavement Specialist Mr. Verma Vijay Kumar, now since copy of the Bachelor of Civil Engineering Degree dated 10.05.2004 is attached with the representation, viewed and considered and evaluated by the committee, accordingly final result updated.

2. The bidder namely M/S. STERLING INDO TECH CONSULTANTS P LTD,, Jaipur in Association with M/s Vital Vertex Value Venture Pvt.Ltd vide letter no SITC/HO/BD/2023-24/3032 dated 23.02.2024 has submitted the representation with respect of Criteria 2 Numbers of key personnel (as defined in RFP) with firm in highway sector with more than one year with the firm, Criteria 5 in hand DPR &, evaluation of CV of Team leader & Senior pavement Specialist.

The representation has been examined by the Evaluation committee and following is brought out:-

- i) The bidder has claimed 10 marks for the Evaluation criteria for Nos of Highway professionals with the firm, submitted that they have 43 key professionals enclosing form no 26AS of the personals, and self-evaluated 10/10 marks under the category at Sr. No. 2 of firm evaluation, No. of Highway professionals with the firm. However, the committee during the Technical evaluation verified these 43 professionals on INFRACON and found only 23 professionals are available on INFRACON, accordingly 9/10 marks have been evaluated by the committee as per RFP criteria, hence committee found no change in the marks evaluated.
- ii) The bidder Submitted that they have 8 Nos of ongoing DPR and its details are submitted on page no 410 to 483 comprising the Clint certificates. Earlier, the











Evaluation committee referred the page no 192 of the uploaded documents on which only list of the assignment along with LOA received currently without the client's certificates, therefore the Committee evaluated Zero mark under the category. Now the pages referred by the bidder have been examined also the undertaking dated 23.02.2024 w.r.t. SH given by the bidder is viewed and committee observed that the projects mentioned at page no 412, 414-422, 446-448, 454-456, 458 to 467 and 469-483 Qualifies under the category and accordingly, 10 marks have been evaluated and updated.

- iii) The bidder has claimed 05 marks for the Evaluation CV of Team Leader under the criteria for O&M projects at Sr. no. P-12,P-14 & P-17, The committee gone through the description of duties given in projects P-12,P-14 & P-17 on infracon portal which does not reflects for O&M works. Accordingly, the committee has reiterated its earlier evaluation of zero marks under the category thus the score remains unchanged of Team Leader.
- iv) The bidder has claimed 20 marks for the Evaluation of CV of Senior pavement Specialist for total professional experience, claiming more than 15 years. The Evaluation Committee re-examined the projects P-1 to P-12 on infracon portal and observed that the professional has experience from 01.09.2008 to 31.01.2022 i.e. for 13 year 4 months and there after a gap of 4 months having experience from 01.06.2022 to 01.05.2023(date of issue of the enclosed certificate) i.e. for 11 months thus total experience of less than 15 years accordingly evaluated 19 marks, hence no change in the score.

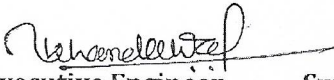
3. The committee considering the above findings updated the technical score of the Technically responsive Bidders are as under:

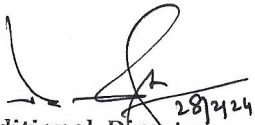

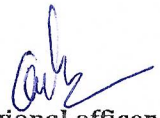
